**Fiscal Policy and Planning Committee**

Committee Chair Marlon Evans convened the Fiscal Policy and Planning Committee.

**4A: Fiscal Report for FY 2009-10 and Report on the Fiscal Outlook of the Commission**

Crista Hill, Director, Administrative Services Division-Fiscal and Business Services Section provided an update on the revenue and expenditures for FY 2009-10 and an update on the fiscal outlook of the Commission.

**Credentialing and Certificated Assignments Committee**

**Sharon Robison, Association of California School Administrators**, endorsed the concept of 32 units for the Foundation-Level General Science.

**6B: Discussion on Accepting Program Coursework for Child Development Permits from Non-Regionally Accredited Entities**

Marilyn Errett, Administrator, Office of Governmental Relations, and Teri Clark, Acting Director, Professional Services Division, presented this item which provided information regarding Child Development Permit requirements, and approval process and current Commission practices related to alternative program providers for other types of credentials.

**Kathy Harris, California Teachers Association**, suggested having an advisory panel look at the alignment of what the Montessori Accreditation Council for Teacher Education (MACTE) program has to offer and compare it to what the state of California asks of its early childhood programs. She also suggested conducting a field survey of early childhood practitioners and higher education experts.

**Sharon Robison, Association of California School Administrators**, suggested forming a stakeholder group to identify the main issues prior to having an advisory panel.

The Commission directed staff to have a study group to evaluate the various factors surrounding the acceptance of coursework from non-regionally accredited entities.
