### **General Session**

Acting Chair Cheung convened the November 8, 2007 General Session of the Commission on Teacher Credentialing. Roll call was taken and the Pledge of Allegiance was recited.

### **2A: Approval of the October 2007 Minutes**

Commissioner Littman moved approval of the October 2007 Minutes. Commissioner Molina seconded the motion. The motion passed without dissent.

### **2B: Approval of the November 2007 Agenda**

Commissioner Gaston moved approval of the Commission's November 2007 Agenda with a revised item 2J and agenda inserts for items 3B and 3E. Commissioner Gomez seconded the motion. The motion passed without dissent.

**2C: Approval of the November 2007 Consent Calendar**

Commissioner Gomez moved approval of the Consent Calendar. Commissioner Whitson seconded the motion. The motion passed without dissent.

**2D: Chair's Report (Part I)**

Chair Cheung introduced Howard Blonsky and Heather Gomez from the California Association of School Social Workers and invited them to the table to share information with the Commission on the duties of school social workers.

Mr. Blonsky and Ms. Gomez gave a brief presentation about the need for collaborative comprehensive student support services for our youth and described their work to provide student support service and promote academic achievement and personal success for students.

Mr. Janssen welcomed Dr. Rebecca Parker and Dr. Wayne Bacer as Consultants and Catherine Creeggan as an Assistant Consultant in the Professional Services Division.

**Fiscal Policy and Planning Committee**

Committee Chair Guillermo Gomez convened the Fiscal Policy and Planning Committee.

**6A: Approval of Agreements Over \$150,000 for Fiscal Year 2007-08**

Crista Hill, Division Director, Fiscal and Business Services Section presented this item requesting the Commission to approve a contract for an upgrade of the Credentialing Automation System Enterprise (CASE) that was implemented as a result of the Teacher Credentialing Improvement Project (TCSIP) in February of 2005.

Commissioner Gaston moved to approve staff recommendation for the Executive Director to execute the agreement as presented. Commissioner Littman seconded the motion. The motion carried without dissent.

**Professional Services Committee**

Acting Committee Chair Leslie Littman convened the Professional Services Committee.

**3A: Program Approval and Initial Institutional Approval**

Teri Clark, Administrator and Helen Hawley, Consultant, Professional Services Division, presented the following programs for Commission approval:

Commissioner Whitson moved to approve the two prospective program sponsors for initial institutional approval and the five single subject matter programs. Commissioner Cheung seconded the motion. The motion carried without dissent.

**3B: Fifth Year of Study Program Standards and the Option of Extending a Preliminary Multiple or Single Subject Credential**

Teri Clark, Administrator and Terry Janicki, Consultant, Professional Services Division, presented this item which requested that the Commission adopt two additional program standards for the fifth year of study programs as well as an implementation timeline for these additional standards, and also endorse the concept of a one time extension of a Preliminary Multiple or Single Subject Credential under specified situations.

**Kathy Harris, California Teachers Association**, asked for clarification on the extension process.

**Mel Hunt, Bonnie Crawford, Tedi Kostka and Carol Riley, Credential Counselors and Analysts of California**, raised some concerns about this process.

**Mary Dolan, Los Angeles County Office of Education**, voiced her support of the proposal.

Commissioner Pearson moved to adopt the two modified standards (Program Standard 5: Advanced Study of K-12 Core Academic Content and Subject Specific Pedagogy, and Program Standard 6: Advanced Study of Supporting Equity, Diversity and Access to the Core Curriculum) to the Fifth Year of Study Program Standards. Commissioner Gaston seconded the motion. The motion carried without dissent.

Commissioner Gomez moved to endorse the concept of a one time three year extension to the Preliminary Multiple or Single Subject Teacher Credential if for specified reasons an individual has not been able to satisfy the requirements for the Clear Credential. Commissioner Molina seconded the motion. The motion carried without dissent.

**3C: Adoption of Standards of Quality and Effectiveness for Health Services: School Nurse Credential Programs**

Phyllis Jacobson Administrator, Professional Services Division presented the draft Standards of Quality and Effectiveness for Health Services: School Nurse Credential Programs for adoption by the Commission.

**Candace Hilvers, Tulare County Office of Education**, thanked the Commission for providing school nurses the opportunity to review, revise and update the School Nurse standards to reflect the current practice and issues.

**Tricia Chicagus, LAUSD**, gave a brief presentation on the work of the Standards Development Panel for the School Nurse Credential Program.

**Beverly Miller, California State University, Fresno**, addressed questions about the standards that were raised at the October Commission meeting.

**Dale Parent, California School Nurses Organization**, thanked staff and panel members for the work that they did on the School Nurse Credential Program Standards.

Commissioner Gomez moved to approve the Standards of Quality and Effectiveness for Health Services: School Nurse Credential Programs. Commission Whitson seconded the motion. The motion carried without dissent.

**3D: Adoption of Content Specifications for the Reading Instruction Competence Assessment (RICA)**

Yvonne Novelli, Assistant Consultant, Professional Services Division, presented this item which provided the draft RICA content specifications for the Commission's approval and a proposed timeline for the implementation of a revised RICA examination.

**Dr. Elva Duran and Dr. John Shefelbine, RICA Design Team**, addressed the some concerns that were raised at the October Commission meeting.

**Kathy Harris, California Teachers Association**, voiced her concerns on the timeline if the Commission takes immediate action on this issue.

Commissioner Pearson moved to adopt the Content Specifications for the Reading Instruction Competence Assessment with two modifications: 1) add "love of reading" after "background knowledge" on page PSC 3D-22 under number (6); and 2) add "as a pathway to healthy life long reading habits" at the end of the sentence under number (11) on page PSC 3D-25. Commissioner Gomez seconded the motion. The motion carried without dissent.

Acting Chair Cheung announced that Ex-Officios Gallagher and Sloan were appointed as voting members of the Commission for the rest of the meeting.

**3E: Draft Report on the Study of Special Education Certification**

**Kathryn Benson, Pleasanton Unified School District**, encouraged the Commission to support the changes to the Short-Term Staff Permit.
