### **General Session**

### **2A: Approval of the January-February 2008 Minutes**

Commissioner Gomez moved approval of the January-February 2008 Minutes. Commissioner Gaston seconded the motion. The motion passed without dissent.

### **2B: Approval of the March 2008 Agenda**

Commissioner Littman moved approval of the Commission's March 2008 Agenda with an agenda insert for item 3B. Commissioner Cheung seconded the motion. The motion passed without dissent.

### **2C: Approval of the March 2008 Consent Calendar**

Commissioner Gaston moved approval of the Consent Calendar. Commissioner Whitson seconded the motion. The motion passed without dissent.

**2D: Chair's Report**

Chair Pearson announced that Commission Whitson would chair for both the Professional Services Committee and the Professional Practices Committee due to Commissioner Cordeiro's absence.

**2E: Executive Director's Report**

Executive Director Dale Janssen announced the appointment of Crista Hill as the Director of the Administration Division. He also informed the public that coded correspondence dating back to 1975 are now available on the Commission website with an enhanced search engine feature.

**Professional Services Committee**

Acting Committee Chair Loretta Whitson convened the Professional Services Committee.

**3A: Proposed Adoption of the Revised Experimental Program Standards**

Cheryl Hickey, Consultant and Larry Birch, Director, Professional Services Division, presented this item which provided revised Experimental Program Standards to the Commission for adoption.

**Dr. Barbara Merino, University of California, Davis**, assisted the staff in answering questions regarding the proposed experimental program standards.

Commissioner Littman moved to approve the staff recommendation to adopt the proposed revised Experimental Program Standards. Commissioner Pearson seconded the motion. The motion carried without dissent.

**3B: Report to the Legislature and the Governor on Career Technical Education (CTE)**

Helen Hawley, Consultant, Professional Services Division, presented this item which provided the Report to the Legislature and Governor on Career Technical Education for Commission approval.

**Paul Waters, California Association of Regional Occupational Centers and Programs**, voiced support of the CTE panel's original recommendation regarding recent work experience and suggested the Commission enhance the proposed program standards survey to include credential requirement information.

**Rick Graham, California Teachers Association**, voiced support of the amended CTE report.

**Sharon Robison, Association of California School Administrators**, echoed the same support.

Commissioner Littman moved to approve the report on Career Technical Education for transmittal to the Legislature and Governor with the following amendments: 1) Recommendation (1), page 3, bullet 4 should read: Expand the requirement for recent work experience to one year in the last five years or two years in the last ten years; 2) Table 1, page 5, #5 of the Preliminary Credential Requirements should read: One year recent work experience in the last five years or two years work

experience in the last ten year; 3) Final Recommendation 7, page 17, should read: The requirement for recency of work experience should be expanded to one year in the last five years or two years in the last ten years with a revised *Rationale* statement. Commissioner Pearson seconded the motion. The motion carried without dissent.

### **3C: Program Approval and Initial Institutional Approval**

Helen Hawley, Consultant, Professional Services Division, presented the following programs for Commission approval:

### **3D: Update on the Induction Standards Review**

Terry Janicki and Karen Sacramento, Consultants, Professional Services Division, presented this item which provided information from the initial meeting of the Induction Standards Design Team.

### **3E: Proposed Revisions to Teacher Preparation Program Standards 7A, 7B, and 8B (d)**

Terry Janicki, Consultant, Professional Services Division, presented this information item which provided proposed revisions to the teacher preparation standards 7A, 7B, and 8B(d) in order to align these program standards with revised specifications for the Reading Instruction Competence Assessment (RICA) examination as well as with the new state Reading/Language Arts Framework.

**Mary-Alicia McRae, Salinas City Elementary School District, and Geri Mohler, California Department of Education,** also assisted the staff in explaining the proposed standards.

**Kathy Harris, California Teachers Association,** gave a couple of suggestions on the draft language for the revised standards and raised concerns on the timeline to prepare the candidates for the RICA exam.

The Commission directed staff to send out the survey regarding the proposed teacher preparation standards to the field and bring back the results at the April Commission meeting for the Commission's consideration.

### **3F: Numbers of Services Credentials Issued in California, 2001-2002 to 2005-2006**

Marjorie Suckow and Rebecca Parker, Consultants, Professional Services Division, presented this information item which provided trends and patterns in numbers of services credentials issued in the past five years.

### **Professional Practices Committee**

**8A: Committee of Credentials: Expiration of Term and Declaration of Vacancy**
