General Session

Chair Ting Sun convened the April 22-23, 2010 General Session of the Commission on Teacher Credentialing. Roll call was taken and the Pledge of Allegiance was recited.

1A: Approval of the March 2010 Minutes

Commissioner McInerney moved approval of the March 2010 Minutes. Commissioner Blackburn seconded the motion. The motion carried without dissent.

1B: Approval of the April 2010 Agenda

Commissioner Littman moved approval of the Commission's April 2010 Agenda with an agenda insert for item 1C. Commissioner Evans seconded the motion. The motion passed without dissent.

1C: Approval of the April 2010 Consent Calendar

Commissioner McInerney moved approval of the Consent Calendar. Commissioner Blackburn seconded the motion. The motion carried with Commissioner Littman abstaining.

1D: Chair's Report

Chair Sun reported that she attended the April meeting of the Committee on Accreditation. Chair Sun congratulated Commissioner Martin for his presentation on Loyola Marymount University's accreditation report.

1E: Executive Director's Report

Executive Director Dale Janssen notified the public of the facility updates and thanked Crista Hill for her leadership on the project.

1F: Commission Member Reports

Commissioner Martin reported that he gave a presentation on the work of the Commission at the Spring 2010 Conference of the California Council on Teacher Education.

Commissioner Oropeza-Enriquez reported that she and Chair Sun attended a policy forum entitled "Strengthening Teaching Practice: The Role and Responsibilities of School Site Leaders," sponsored by the Center for the Future of Teaching and Learning.

1G: Liaison Reports

There were no reports.

Professional Practices Committee

Committee Chair Steven Dean convened the Professional Practices Committee.

2A: Review and Designation of Discipline Precedential Decisions

Mary Armstrong, Director, Professional Services Division, presented this information item which provided examples of the types of decisions that could be designated as precedential and a possible procedure outlining how the Commission would designate decisions.

Harold Acord, California Teachers Association, voiced opposition to the precedential decisions and requested that the Commission drop any further discussions and actions on the topic.

Michael Rothschild, California Teachers Association, opposed the proposal of designation of precedential decisions.

Ken Burt, California Teachers Association, voiced his opposition of the proposal and requested the Commission take the item off the agenda indefinitely.

The Commission directed staff to bring the item back with a process to designate decisions for Commission consideration.

Professional Services Committee

Committee Chair Constance Blackburn convened the Professional Services Committee.

3A: Teacher Supply in California, 2008-2009, A Report to the Legislature

Marjorie Suckow, Consultant, and Teri Clark, Administrator, Professional Services Division, presented this item which provided a report on the number of teachers who received credentials, certificates, permits and/or waivers to teach in California public schools.

Commissioner Chernow moved to approve the report for submission to the Governor and Legislature. Commissioner McInerney seconded the motion. The motion carried without dissent.

3B: Further Discussion of Recommendations from the English Learner Authorizations Advisory Panel

Phyllis Jacobson, Administrator, Professional Services Division, presented this item which provided three specific recommendations from the panel for Commission discussion.

Harold Acord, California Teachers Association, supported the recommendations in general and raised some concerns regarding the authorizations.

Susan Westbrook, California Federation of Teachers, raised concerns regarding the staffing for supporting English learners and requested CTCL be embedded in the authorizations.

David Simmons, Ventura County Office of Education, raised questions regarding the content knowledge requirements and employment issues.

Sharon Robison, Association of California School Administrators, voiced concerns regarding employment issues.

The Commission directed staff to bring the item back with a systematic overview of what a revised system might look like if the panel recommendations were to be implemented.

3C: Draft Preconditions for Audiology and School Nurse Services Credential Preparation Programs

Larry Birch, Director, Professional Services Division, presented this information item which provided one draft precondition for Clinical Rehabilitative Services: Audiology preparation programs, and one draft precondition for School Nurse Services preparation programs.

3E: Draft Content Specifications for the California Preliminary Administrative Credential Examination (CPACE)

Yvonne Novelli, Consultant, and Larry Birch, Director, Professional Services Division, presented this item which provided the draft content specifications for the CPACE for the Commission's initial review and described the next steps in the CPACE development process.

General Session

Chair Sun reconvened the General Session of the Commission.

1H: Empowering Effective Teachers: An Overview of Current Efforts to Support the Field

Greg Sommers, Senior Program Officer, Bill & Melinda Gates Foundation, and Cristina de Jesus, Chief Academic Officer, Green Dot Public Schools gave an overview of two related initiatives to improve teacher effectiveness: The Measures of Effective Teaching research project and the Intensive Partnerships to Empower Effective Teaching and the efforts of The College-Ready Promise.

Professional Services Committee

Committee Chair Constance Blackburn reconvened the Professional Services Committee.

3F: Update on the Implementation of the Revised *California Standards for the Teaching Profession* (CSTP)

Terry Janicki, Administrator, and Karen Sacramento, Consultant, Professional Services Division presented this item which provided an update on the dissemination of the recently revised *California Standards for the Teaching Profession* (CSTP) and on plans for continued development of Induction-related materials based on the CSTP.

3D: Update on the Development of the Plan for the Implementation of SBX5 1

Marilyn Errett, Administrator, Office of Governmental Relations, and Teri Clark, Administrator, Professional Services Division, presented this item which provided information about SBX5 1, related to the development of a possible alternative process for entities that would like to offer educator preparation in California but do not hold regional accreditation.

Donna Glassman-Sommer, California Teacher Corps, voiced support of the alternative certification program and offered the Commission their technical support for the new entities under this legislation to provide high quality teacher preparation programs.

Susan Westbrook, California Federation of Teachers, said that option 1, an adaption of the process used by WASC, would be an appropriate alternative for new entities to meet the teacher preparation program standards.

Harold Acord, California Teachers Association, voiced CTA's opposition of SBX5 1 but supported option 1 and option 2 for new entities to meet the same standards required of the current preparation programs.
