General Session

Chair Ting Sun convened the June 3, 2010 General Session of the Commission on Teacher Credentialing at 9:07 a.m. Roll call was taken and the Pledge of Allegiance was recited.

2A: Approval of the April 2010 Minutes

Commissioner Chernow moved approval of the April 2010 Minutes. Commissioner Blackburn seconded the motion. The motion carried without dissent.

2B: Approval of the June 2010 Agenda

Commissioner Blackburn moved approval of the Commission's June 2010 Agenda with agenda inserts for items 2C, 3B and 5C. Commissioner Gahagan seconded the motion. The motion passed without dissent.

2C: Approval of the June 2010 Consent Calendar

Commissioner Chernow moved approval of the Consent Calendar. Commissioner Littman seconded the motion. The motion passed without dissent.

2D: Chair's Report

Chair Sun reported that she and Commissioner Oropeza-Enriquez attended the school leadership forum on Strengthening Teaching Practice: The Role and Responsibilities of School Site Leaders sponsored by the Center for the Future of Teaching and Learning on May 17.

2E: Executive Director's Report

Executive Director Dale Janssen reminded the public of the "Working Collaboratively for Teacher & Student Success" seminar on June 23 in San Jose that will be co-sponsored by the Commission, the California Department of Education, the California County Superintendents Educational Services Association and the California Postsecondary Education Commission.

Mr. Janssen also announced that the Office of Administrative Law approved a portion of the Special Education Title 5 Regulations. He informed the public that language pertaining to the Communication Development Credential and the Speech Language Pathology Services Credential were withdrawn from the original regulatory package and would be brought back for public hearing at a later date.

2H: Proposed Amendments to 5 California Code of Regulations §80001 Pertaining to Definitions and Terms

Tammy Duggan, Credential Specialist, Certification, Assignment and Waivers Division, presented this item which provided proposed amendments to 5 California Code of Regulations §80001 pertaining to Definitions and Terms in relation to application forms.

Chair Sun solicited input from the Commissioners and the public.

There was no public input.

Commissioner Blackburn moved to adopt the proposed amendments to 5 California Code of Regulations pertaining to Definitions and Terms in relation to application forms. Commissioner Chernow seconded the motion. The motion carried without dissent.

Legislative Services Committee

Committee Chair Charles Gahagan convened the Legislative Services Committee.

3A: Status of Legislation

Marilyn Errett, Administrator, Office of Governmental Relations, presented this item which provided an update on the status of bills on which the Commission has adopted a position.

3B: Analyses of Bills

Mary Armstrong, Director, Office of Governmental Relations, presented an analysis of AB 2685 (De La Torre).

Commissioner Sun moved to take a position of "Support" on AB 2685. Commissioner Castillo seconded the motion. The motion carried without dissent.

Credentialing and Certificated Assignments Committee

Committee Chair Irene Oropeza-Enriquez convened the Credentialing and Certificated Assignments Committee.

4A: Proposed Amendments to 5 California Code of Regulations Pertaining to Multiple and Single Subject Teaching Credentials for Out-of-State Credentialed Teachers

Tammy Duggan, Credential Specialist, Certification, Assignment and Waivers Division, presented this item which provided proposed amendments pertaining to Multiple and Single Subject Teaching Credentials for out-of-state trained teachers to align the regulations with statute.

Kathy Harris, California Teachers Association, asked staff to clarify the requirements regarding individuals from U.S. territories.

Commissioner Gahagan moved to approve the proposed amendments to 5 California Code of Regulations §§80413.3 and 80430.2 for the purpose of beginning the rulemaking file for submission to the Office of Administrative Law and for scheduling a public hearing with the following additional language change to §80413.3(a)(2)(B)(1): A master's or higher degree in a field related to the credential or the equivalent number of graduate level semester units earned at a regionally accredited institution of higher education and verified by official transcript. Commissioner Sun seconded the motion. The motion carried without dissent.

4B: Preliminary Multiple and Single Subject Teaching Credential Extension Options

Terri Fesperman, Consultant, Certification, Assignment and Waivers Division, and Karen Sacramento, Consultant, Professional Services Division, presented this item which provided an update on the implementation of the regulations that allow for an extension of time for specific multiple and single subject credential holders.

Professional Services Committee

Committee Chair Constance Blackburn convened the Professional Services Committee.

5A: Adoption of Proposed Preconditions for Audiology and School Nurse Services Credential Preparation Programs

Larry Birch, Director, Professional Services Division, presented this item which provided one proposed Precondition for Clinical Rehabilitative Services: Audiology preparation programs and one proposed Precondition for School Nurse Services preparation programs.

Commissioner McNerney moved to adopt the proposed preconditions for the Clinical Rehabilitative Services: Audiology and the School Nurse Services credential preparation programs. Commissioner Oropeza-Enriquez seconded the motion. The motion carried without dissent.

5B: Adoption of the Plan for the Implementation of SBX5 1

Teri Clark, Administrator, Professional Services Division, presented this item which provided the plan for implementation of SBX5 1 as recommended by the Committee on Accreditation (COA).

Lynne Cook, Committee on Accreditation, assisted staff in presenting this item.

Kathy Harris, California Teachers Association, voiced concerns regarding fees and the monitoring process; asked for clarification on what is discretionary what is required; asked for additional

information on the potential organizations that are interested in pursuing this option; and requested the Commission delay final action to allow additional time for review and revision.

Commissioner Gahagan moved to adopt the four recommendations forwarded from the Committee on Accreditation with the following changes: 1) bullet #2: change the word 'sentences' to 'components' and 2) bullet #4: remove the word 'possibly'. Commissioner Sun seconded the motion. The motion carried without dissent.

The Commission also directed staff to bring back an agenda item with a defined proposed implementation process and the cost associated with the full initial review process for those prospective entities.

5C: Adoption of Content Specifications and Domain Weighting for the California Preliminary Administrative Credential Examination (CPACE)

Yvonne Novelli, Consultant, and Larry Birch, Director, Professional Services Division, presented this item which provided the recommended content specifications and domain weighting for the CPACE examination. The item also described the next steps in the CPACE development process.

Nancy Brownell and Stephen Davis, CPACE Examination Development Team, assisted staff in presenting this item.

Kathy Harris, California Teachers Association, requested clarification regarding the alignment of the standards with the content specifications, the timeline associated with revising the program standards and the important notes about the CPACE Content Specifications for the examples listed under each domain that were included in the previous agenda item.

Commissioner Sun moved to approve the draft CPACE content Specifications and the weighting for the CPACE examination domains. Commissioner Gahagan seconded the motion. The motion carried with Commissioner Chernow abstaining.

5D: Update on the Work of the Teaching Mathematics Advisory Panel and Introduction of Draft Standards

Rebecca Parker, Consultant, and Terry Janicki, Administrator, Professional Services Division, presented this item which provided an update on the work of the Teaching Mathematics Advisory Panel; proposed changes to the structure of the mathematics specialist authorization; and proposed draft program standards for the revised authorizations as well as for the mathematics pedagogy preparation of multiple subject credential candidates.

David Simmons and Pam Tyson, Mathematics Advisory Panel, assisted staff in presenting this item.

5E: Draft Revised Standards for the Reading Certificate and Reading and Language Arts Specialist Credential Programs

Rebecca Parker and Geri Mohler, Consultants, Professional Services Division, presented this item which provided a second draft of the revised standards for the Reading Certificate and Reading and Language Arts Specialist Credential Preparation Programs after changes based on field survey comments.

5F: Recommendations from the Subject Matter Advisory Panel

Helen Hawley, Consultant, and Teri Clerk, Administrator, Professional Services Division, presented this item which provided recommendations from the Subject Matter Advisory Panel.

Harold Acord, California Teachers Association, stated his support of the recommendations. He also supported the suggestion to add additional language on diversity and equity.

The Commission directed staff to bring an agenda item back in August for Commission consideration and action. The Commission also directed staff to include information on additional areas of concern regarding the subject matter approval process.

Chair Sun reconvened the General Session.

2I: Report of Ad Hoc Committee

Chair Sun reported that the Committee recommended to the full Commission the appointment of Gregg Law to serve as the elementary teacher member and Tillie Soliz to serve as a public member on the Committee of Credentials commencing July 1, 2010. The Committee further recommended that Albert Dolata be appointed as an alternate for the Committee of Credentials.

The motion carried without dissent.

2J: New Business

The Quarterly Agenda was presented.
