Fiscal Policy and Planning Committee

Introduction

Section 610 of the CTC Policy Manual (Contract Authority) requires that agreements or contracts of \$150,000 or more be approved by the Commission on Teacher Credentialing (Commission).

Background

As part of daily operations Commission staff has to work with various external vendors to complete some of the tasks in order to access needed expertise in the field. When an agreement, as specified in Section 610, exceeds \$150,000 Commission staff must seek approval from the Commission prior to entering into the agreement.

Requested Action by the Commission

At this time, Commission staff seeks the Commission's consideration and action on the approval for the Executive Director to execute an amended agreement with Renne, Sloan, Holtzman, Sakai LLP for a total contract of \$250,000. Renne, Sloan, Holtzman, Sakai LLP is providing legal services for the pending litigation in *Carroll v Commission on Teacher Credentialing* (SPB 11-0739). The term of the agreement is proposed from May 2, 2011 – September 30, 2012, given the nature of the services being provided.

Recommendation

Commission staff seeks the approval for the Executive Director to execute the amended agreement with Renne, Sloan, Holtzman, Sakai LLP for a total of \$250,000 and the term of May 2, 2011 – September 30, 2012.
