# Program Approval

## **Introduction**

This agenda item presents one single subject matter program submitted by an institution of higher education for approval.

## **Background**

The Commission regularly receives recommendations for program approval from single subject matter review panels. These panels of subject matter experts review all program documentation and make an informed determination whether the program meets the standards common to all subject matter programs and also the content specific subject matter standards. The content specific subject matter standards are closely aligned to the K-12 academic content standards. These subject matter programs are usually undergraduate courses of study completed before candidates begin teacher preparation programs. However, the two programs may be completed concurrently.

## **Subject Matter Program Review Procedures**

Following are the general procedures for the review of subject matter programs:

1. Technical Assistance – After the Commission adopts a set of new program standards, Commission staff members provide technical assistance to prospective program sponsors wishing to submit responses to the new standards. Technical assistance materials are provided on the Commission’s website. Staff members train, assign, and coordinate review team work.
2. Preconditions Review – After the program proposal is received, Commission staff review the sponsor’s response to the preconditions. The preconditions are based on both state laws and Commission policies, and address minimum unit and content area requirements. If the preconditions response is incomplete, the sponsor is requested to provide specific information necessary for compliance with the preconditions.
3. Program Review – The program sponsor’s responses to the Commission’s subject matter program standards are reviewed by a team of two or more subject matter educators to determine if the program meets the program standards, including the subject matter requirements (SMRs). The SMRs are the content knowledge required to be covered in the program and are aligned to the K-12 content standards that the candidate will be expected to know. The reviewers are trained in the alignment of the standards and subject matter requirements and in the review process before they are assigned proposals to review. Reviewers are instructed to find explicit evidence that programs not only align with K-12 content

standards but also introduce their candidates to those standards within the context of their subject matter studies. The team must reach consensus that each standard is met based upon evidence provided in the document. If the program does not meet the standards, the sponsor is given an explanation of the findings. The sponsor may then submit the additional information requested. Once reviewers determine that the program proposal provides a convincing and adequate body of evidence to meet the Commission's adopted subject matter program standards, the program is recommended to the Commission for approval.

4. After subject matter program approval is granted by the Commission, the institution may admit candidates to the approved subject matter program. Graduates of a Commission approved single subject matter preparation program meet the Commission's subject matter requirement and are not required to take the subject matter examination (California Subject Examinations for Teachers).

This report presents one single subject matter program that has been deemed to have met all of the appropriate *Standards of Quality and Effectiveness for Single Subject Matter Preparation Programs* ([www.ctc.ca.gov/educator-prep/STDS-subject-matter.html](http://www.ctc.ca.gov/educator-prep/STDS-subject-matter.html)) by appropriate review panels and is recommended to the Commission for approval. The program brought forward to the Commission for approval at this time is: California State University, Northridge, Single Subject Matter: Social Science Chicano Studies

### **Summary Information on the Proposed Single Subject Matter Program**

#### *California State University, Northridge Single Subject Matter Program: Social Science*

The California State University Northridge (CSUN) Chicana/o Studies Department's undergraduate Social Science Subject Matter Program (Bachelor of Arts) is designed to prepare prospective teachers of Social Science/History to teach students who attend California public schools. The program engages prospective teachers in core and extended study courses that are aligned with and build upon the State-adopted History-Social Science Content Standards and the History-Social Science Framework. Future teachers practice relevant history social science tools, methods, and skills and are introduced to important concerns in schools such as addressing the needs of Second Language Learners, special needs, and diverse students.

Core coursework includes Economic Principles and Problems, World Geography, and California Geography, as well as U.S. History, World History, History of the Americas, African American History, Chicana/o History, and American Political Institutions. These courses provide prospective teachers with a solid grasp of social science/history subject matter, academic literacy and discipline-based fluency. Students also enroll in courses that provide depth in geography, history, political science, and equity and diversity. Prospective teachers engage in field-based activities that support them in reflecting on and comprehending the real world of social science/history teaching. Typically in their senior year students enroll in the capstone research methods course during which they employ social science/history tools and research processes for the purpose of critically investigating educational policies and practices and their impact on students. The CSUN

Chicana/o Studies Department employs student learning outcomes and assessment procedures delineated by California State University Northridge and the Western Association of Schools and Colleges (WASC). Students in the program maintain a professional portfolio that demonstrates how course and field-based activities are aligned with appropriate state standards.

**Recommendations**

Based upon a determination by reviewers that the following entity has met all relevant standards and requirements, staff recommends Commission approval of the following subject matter program: California State University, Northridge: Social Science
