Subject: New Reading and Literacy Added Authorization and Reading and Literacy Specialist Credential Program Standards

Summary

This notice is to alert all interested parties that on September 30, 2010, the Commission on Teacher Credentialing approved revised standards for, and renamed, the Reading Certificate and Reading and Language Arts Specialist Credential to become the Reading and Literacy Added Authorization and Reading and Literacy Specialist Credential. Included in this PSA is a link to a web page for information on the process of developing these standards, the standards themselves, as well as forms and assistance for transitioning to the new standards.

Background

In keeping with the Commission's policy of reviewing all program standards every ten years, the Executive Director of the Commission was charged to convene an advisory panel of reading teaching specialists, both those in the classroom and those who prepare individuals to teach reading. The panel was charged with the task of reviewing the 1998 program standards, the revised Reading Instruction Competence Assessment (RICA) content specifications, and the revised Multiple and Single Subject Teacher Preparation Program Standards 7A (Preparation to Teach Reading-Language Arts for Multiple Subject Candidates), 7B (Preparation to Reading-Language Arts for Single subject Candidates), and 8B(d) (Pedagogical Preparation for Subject-Specific Content Instruction by Single Subject English Candidates) to determine changes to the 1998 program standards.

The panel was convened in June 2008 and met over a period of two years before finalizing the revised program standards that were adopted on September 30, 2010.

Some of the major differences or added emphases in the 2010 standards as compared to the 1998 standards are:

- Focus on a Culture of Literacy, not just Reading, which includes Writing, Speaking & Listening and the setting
- All domains are included—not just fluency and comprehension as before
- Research-based best practices
- Response to Instruction and Intervention (RtI²) model
- Use of data
- Increased focus on Pre-kindergarten & adolescent literacy
- Leadership/Coaching/Adult Learning Theory (working with other teachers)
- Assessment of Candidate Competence
- Information/Technology literacies and K-12 library content standards

Current approved programs must transition to the 2010 standards by January 2013.
