The Commission for Teacher Preparation and Licensing will conclude its pilot project on institution issuance of Multiple and Single Subject five-year preliminary or clear teaching credentials. To facilitate the termination of the pilot project, please submit all application packages from the fall semester, or the winter quarter 1977 to Janet Oliver, c/o Commission for Teacher Preparation and Licensing, 1020 "O" Street, Room 222, Sacramento, California 95814, no later than March 15, 1978.

The Commission has authorized the continuation of institutional processing of these same credential types beyond the pilot phase as an on-going project. In view of the continuation of this project, currently participating institutions wishing to continue are requested to retain all unused credential documents so they can be used for the on-going project. To supply us with information for an interim audit of documents, please provide the information regarding credentials still in your possession on the attached questionnaire.

In addition to the continuation project, the Commission has ~~authorized a new pilot phase which will permit approximately~~ five institutions currently participating, to issue additional credential types. Institutions that will participate in this new pilot phase will be selected from the group of institutions that have participated in the initial project and who express an interest in participating in the new pilot phase.

Institutions selected for participation in the new pilot phase will be notified as soon as the decision is made.
