SUBJECT: Institutions Approved to Offer Special Education
Training for Teachers and Administrators

As you know, AB 1250, section 67.5 of the 1977 Statutes, requires the Commission for Teacher Preparation and Licensing to assure that all teachers and administrators, after July 1, 1979, have training in the areas of special education. While not much lead time was provided before the enactment of this statute, I want to personally commend each of the institutions that have given this top priority and have submitted program plans to the Commission for approval.

I am enclosing a list of the institutions and specific credential programs that have been approved as of August 3, 1979. This list will assist you in counseling and advising current and potential candidates accurately with regard to meeting this requirement. This list will be updated after the September and October Commission meetings.

Thanks again for your continued cooperation and the manner in which you responded to this important piece of legislation.
