Recommended Actions: To extend the terms of the nine continuing members of the COA as described in the item and to select three new members of the Committee on Accreditation (COA).

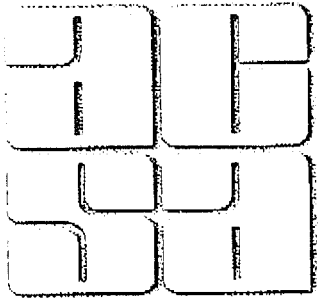
