Program Approval

Introduction

This agenda item presents three elementary subject matter programs and one single subject matter program submitted by institutions of higher education for approval.

Background

The Commission regularly receives recommendations for program approval from subject matter review panels. The content specific subject matter standards are closely aligned to the K-12 academic content standards. These subject matter programs are usually undergraduate courses of study completed before candidates begin teacher preparation programs. However, the two programs may be completed concurrently.

Subject Matter Program Review Procedures

Subject matter educators review the submitting institution's response to the preconditions. The preconditions are based on both state laws and Commission policies, and address minimum unit and content area requirements. The institution's responses to the Commission's subject matter program standards are reviewed by a team of two or more subject matter educators to determine if the program meets the program standards, including the subject matter requirements (SMRs). The SMRs are the content knowledge required to be covered in the program and are aligned to the K-12 content standards that the candidate will be expected to know. If the program does not meet the standards, the institution is given an explanation of the findings. The institution may then submit the additional information requested. Once reviewers determine that the program proposal provides a convincing and adequate body of evidence to meet the Commission's adopted subject matter program standards, the program is recommended to the Commission for approval. After subject matter program approval is granted by the Commission, the institution may admit candidates to the approved subject matter program. Graduates of a Commission approved subject matter preparation program meet the Commission's subject matter requirement and are not required to take the subject matter examination (California Subject Examinations for Teachers).

Summary Information on the Proposed Elementary Subject Matter Programs

California State University, Fresno

The Elementary Subject Matter (ESM) program in the Kremen School of Education and Human Development (KSOEHD) at California State University, Fresno is designed as a Liberal Studies degree program, whose department mission is to provide relevant and rigorous subject matter preparation for elementary teaching that is committed to equity and social justice. The courses in the Liberal Studies program provide prospective teachers with conceptual knowledge of the defined subject matter, fulfilling the California subject matter requirements, with commitments

to teaching for social justice, culturally sustaining pedagogy, and universal design for learning. The Liberal Studies Department works closely with faculty from departments across the campus, community organizations, and local schools. At various points within their learning experiences, students are afforded rich service-learning and field experiences that span grades K-8.

The ESM program consists of 91 required units of lower and upper-division coursework, with a total of 120 units. The ESM program includes the requirement of a 12-unit concentration. Four 12-unit concentration areas are included within the required 91 units. The subject matter requirements are all addressed in the 91 core units, required of all students in the major.

California State University, Sacramento

California State University, Sacramento's (Sacramento State) Elementary Subject Matter (ESM) program will be available through undergraduate majors in Liberal Studies and Child Development Integrated Pre-Credential. Future teachers will take courses that fulfill ESM core requirements in Reading, Language and Literature; Mathematics; Science; Social Science; Visual and Performing Arts; Health and Kinesiology; and Human Development. In addition, candidates will be required to complete elementary field experience. The ESM program will fulfill Sacramento State general education and major requirements. In addition to ESM requirements, the candidates will complete 12 units in one of the following focus areas: Linguistics and Composition; Literature; Mathematics; Natural Science; World History; U.S. History; American Studies; California Studies; Multicultural Studies; Art; Theatre; Music; Physical Education; or Human Development. All candidates in both majors must complete a minimum of 120 units and meet the University foreign language requirement in order to earn a Bachelor of Arts degree.

Vanguard University

Vanguard University's Elementary Subject Matter (ESM) program will provide Liberal Studies majors a comprehensive pathway to demonstrate mastery of ESM program requirements while candidates move through the undergraduate major. The Liberal Studies department developed an active partnership with key programs at the university to ensure that courses are aligned with the ESM program requirements. This interdisciplinary partnership will expand from the infrastructure that has reinforced collaboration to support several established single subject matter waiver programs: English, Math, and Music. The Teacher Education Committee promotes coordination among faculty and staff to ensure that each ESM program standard is covered, practiced and assessed to assure student mastery. Faculty and university advisors will work closely with candidates on how to complete the required curriculum across departments. In addition, candidates will receive information and guidance on all Teacher Education requirements as they progress through their bachelor's degree.

The ESM program consists of 84 units and candidates choose a concentration of study in one of the twelve content areas. Vanguard University's ESM program ensures the quality of candidates' undergraduate experience as they gain competence and content knowledge to better prepare them to become teachers who can effectively teach in schools that promote the development of 21st century skills, which focuses on information literacy and interdisciplinary thinking.

Summary Information on the Proposed Single Subject Matter Program

University of California, Davis

The University of California, Davis' subject matter program in Agriculture will be part of the Agriculture and Environmental Education (AEE) major and offered in the College of Agriculture and Environmental Sciences. The program will develop competence in six key areas of agriculture: Agriculture Business (Economics), Agriculture Mechanics (Applied Biological Systems Technology), Animal Science, Environmental (Ornamental) Horticulture, Environmental Science/Natural Resources, and Plant Science. Candidates will be prepared with content area knowledge to teach Agriculture Education in 7th-12th grade classrooms. Candidates will complete 32 upper division units in the six areas above, and also select an area of specialization and complete 16 units in one specific area. After completing the program and a bachelor's degree in AEE, candidates will be ready to enroll in the credential program.

Throughout the program, candidates will address the natural and social science principles associated with the various disciplines that undergird agricultural and environmental systems. Candidates will learn to obtain the basic skills necessary to interpret, gather and contribute to solving problems as a team member, collaborators, and community organizers. Lastly, candidates will learn how to effectively communicate (orally and in writing) agriculture and environmental concepts and issues with others.
