## **Program Approval**

#### Introduction

This agenda item presents two single subject matter preparation programs submitted by an institution of higher education for approval.

#### Background

The Commission regularly receives recommendations for program approval from subject matter review panels. The content specific subject matter standards are closely aligned to the K-12 academic content standards. These subject matter programs are usually undergraduate courses of study completed before candidates begin teacher preparation programs. However, the two programs may be completed concurrently.

#### **Subject Matter Program Review Procedures**

Subject matter educators review the submitting institution's response to the preconditions. The preconditions are based on both state laws and Commission policies, and address minimum unit and content area requirements. The institution's responses to the Commission's subject matter program standards are reviewed by a team of two or more subject matter educators to determine if the program meets the program standards, including the subject matter requirements (SMRs). The SMRs are the content knowledge required to be covered in the program and are aligned to the K-12 content standards that the candidate will be expected to know. If the program does not meet the standards, the institution is given an explanation of the findings. The institution may then submit the additional information requested. Once reviewers determine that the program proposal provides a convincing and adequate body of evidence to meet the Commission's adopted subject matter program standards, the program is recommended to the Commission for approval. After subject matter program approval is granted by the Commission, the institution may admit candidates to the approved subject matter program. Graduates of a Commission approved subject matter preparation program meet the Commission's SMRs and are not required to take the subject matter examination (California Subject Examinations for Teachers).

#### Summary Information on the Proposed Single Subject Matter Preparation Programs

#### University of California, Santa Barbara

The University of California, Santa Barbara (UCSB) will offer a Subject Matter Preparation Program (SMPP) in Mathematics. The SMPP will be housed in the Department of Mathematics, but course offerings will come from additional departments such as the Department of Probability and Statistics and the Department of Education. The SMPP in Mathematics will provide undergraduate students with an advanced level of mathematics knowledge and skills from the core domains for California secondary mathematics

classrooms: Number and Quantity, Algebra, Geometry, Probability and Statistics, Calculus and History of Mathematics. Candidates will complete 45 quarter-units of work in these areas. The design of the program is aligned with the Bachelor of Arts in Mathematics with Concentration in High School Teaching offered by the Department of Mathematics. Candidates will engage in mathematics content at a high level, and they will develop the practices of mathematics such as persevering in problem solving and constructing arguments.

The SMPP in Mathematics also requires a minimum of 25 quarter-units in coursework that provides breadth and perspective to supplement and enhance the core mathematics content. Candidates will demonstrate knowledge in computer science and physics. They will also study theories of teaching and learning in mathematics education courses, and these courses fulfill requirements for the Minor in Science and Mathematics Education offered by the Department of Education. The SMPP in Mathematics is a program of study that will prepare students to enter credential programs in secondary mathematics.

#### University of California, Santa Barbara

The University of California, Santa Barbara (UCSB) will offer a Subject Matter Preparation Program (SMPP) in Foundational-Level Mathematics. The SMPP will be housed in the Department of Mathematics, but course offerings will come from additional departments such as the Department of Probability and Statistics and the Department of Education. The SMPP in Foundational-Level Mathematics will provide undergraduate students with an advanced level of mathematics knowledge and skills from the core domains for California secondary mathematics classrooms: Number and Quantity, Algebra, Geometry and Probability and Statistics. Candidates will complete 33 quarter-units of coursework in these areas. The design of the program is aligned with the Minor in Mathematics for High School Teaching offered by the Department of Mathematics. Candidates will engage in mathematics content at a high level, and they will develop the practices of mathematics such as persevering in problem solving and constructing arguments.

The SMPP in Foundational-Level Mathematics also requires 19 quarter-units in coursework that provides breadth and perspective to supplement and enhance the core mathematics content. Candidates will study theories of teaching and learning in mathematics education courses, and these courses fulfill requirements for the Minor in Science and Mathematics Education offered by the Department of Education. The SMPP in Foundational-Level Mathematics is a program of study that will prepare students to enter credential programs in secondary mathematics.
