#### Thursday, November 29, 2018

#### **General Session**

Chair Linda Darling-Hammond convened the November 29-30, 2018 General Session of the Commission on Teacher Credentialing at 9:02 a.m. Roll call was taken and the Pledge of Allegiance was recited.

Chair Darling-Hammond introduced Andrew Wall as the new Ex-Officio member representing the Association of Independent California Colleges and Universities (AICCU) and Aya Shhub as the new Educator Preparation Student Liaison to the Commission.

#### 2A: Approval of the September 2018 Minutes

<u>Commissioner Cooney moved approval of the September 2018 Executive Committee Meeting</u> <u>minutes. Commissioner Klatt seconded the motion. The motion carried without dissent.</u>

<u>Commissioner Rodriguez moved approval of the September 2018 Commission Meeting minutes</u> with corrections of three typographical errors. Commissioner Barnes seconded the motion. The motion carried without dissent.

#### 2B: Approval of the November 2018 Agenda

<u>Commissioner Barnes moved approval of the November 2018 Agenda with agenda inserts for items</u> <u>1A, 2H and 3B. Commissioner Marks seconded the motion. The motion carried without dissent.</u>

#### 2C: Approval of the November 2018 Consent Calendar

<u>Commissioner Allavie moved approval of the November 2018 Consent Calendar with an</u> <u>amendment to withdraw item 5. Henry Armenta Jr. to be reviewed during Closed Session.</u> <u>Commissioner Kung seconded the motion. The motion carried without dissent.</u>

#### 2D: Chair's Report

Chair Darling-Hammond sent thoughts and prayers for the people affected by the Camp Fire.

#### 2E: Executive Director's Report

Executive Director Mary Vixie Sandy introduced Cara Mendoza as a new Consultant in the Professional Services Division.

Executive Director Sandy congratulated Catherine Kearney on her upcoming retirement.

Executive Director Sandy updated the Commission on the progress of the performance assessments development.

#### **2F: Commission Member Reports**

Commissioner Rodriguez shared a note from Commissioner Escobedo about what she witnessed on the front lines of the Camp Fire crisis.

Commissioner Barnes stated that the California Association of School Counselors received a message from the Butte County Office of Education to ask any available counselors, mental health and social workers to help the students and families.

Chair Darling-Hammond gave a brief report on the results of the evaluation of Executive Director Mary Vixie Sandy.

#### 2G: Liaison Reports

Commissioner Browne reported that the California Community College Early Childhood Education Executive Board would be meeting on November 30, 2018.

#### **Educator Preparation Committee**

Chair Darling-Hammond appointed Commissioner Kevin Kung to serve as Acting Committee Chair due to Commissioner Jose Gonzalez's absence.

Acting Committee Chair Kevin Kung convened the Educator Preparation Committee.

#### 3A: Annual Report of the Committee on Accreditation

Cheryl Forbes, Committee on Accreditation Member, and Cheryl Hickey and Catherine Kearney, Administrators, Professional Services Division, presented this item which provided the 2017-18 Annual Accreditation Report from the Committee on Accreditation (COA).

#### 3C: Assignment Monitoring of Certificated Staff in California by County Office of Education 2015-17, A Report to the Legislature

Roxann Purdue, Consultant, Professional Services Division, presented this item which provided data collected by the Commission from the county offices of education and addressed the assignment of teachers and other certificated staff in California as required by Education Code (EC) §44258.9.

<u>Commissioner Hinde moved to approve the Assignment Monitoring of Certificated Employees in</u> <u>California by County Offices of Education 2015-17 report for transmittal to the Governor and the</u> <u>Legislature. Commissioner Rodriguez seconded the motion. The motion carried without dissent.</u>

#### 3D: Update on Work Related to the Intern Program Early Completion Option

Teri Clark, Director, Professional Services Division, presented this item which provided an overview of current statutory provisions enabling teaching interns to complete an intern preparation program early based on successful demonstration of readiness to teach as measured on various assessments. This item also included options to pursue changes to the current statute for Commission consideration.

**Danette Brown, California Teachers Association,** asked staff a clarification question and voiced support of this item.

<u>Commissioner Darling-Hammond moved to approve the proposed changes to the current statute</u> and to modify section (c) listed on page EPC 3D-5 as follows: An Intern who participates in the Early Completion Option must continue in all coursework and be supervised and receive support until the passage of a teaching performance assessment. Commissioner Rodriguez seconded the motion. The motion carried without dissent.

#### 3E: Update on Work Related to the Child Development Permit

Erin Sullivan, Consultant, Professional Services Division, presented this item which provided an update on the work related to the Commission's Child Development Permit.

Nancy Hurlbut, Partnerships for Education, Articulation and Coordination through Higher Education (PEACH), spoke about the importance of including the concepts of social-emotional development, exceptional needs, play as intentional language, family engagement, and health and safety within the Performance Expectations and Program Guidelines in Early Childhood Education (ECE). She also emphasized the importance of including early childhood education as a career ladder pathway.

**Jan Fish, PEACH,** agreed with the reports cited in this agenda item to increase depth and breadth of competencies, knowledge, skills, and dispositions in preparation so that early childhood educators share position, compensation, and preparation parity with other educators. She suggested the need for preparation systems to inform each other to build child skills and improve learning outcomes at ages 0-8 and requested continued inclusion of ECE specialists in the development of the Teaching Performance Expectations (TPEs).

Toni Isaacs, PEACH, spoke in support of the need for early childhood specific competencies.

**Carolyne Crolotte, Early Edge California,** thanked the Commission for moving California towards a competency-based early educator preparation system.

Antonia Lopez, Campaign for Quality Early Education, asked the Commission to be cautious on relying on the current dual language learner competencies and requested the opportunity to be involved in the process.

**Josefina Notsinneh, Children Now,** stated that it is critical for the Commission to revise the current permit matrix and suggested the work group reconvene to take a fresh look at the recommendations.

Lyn Scott, California Association for Bilingual Teacher Education, spoke about the emphasis on dual language learners.

#### 3B: Update on State-Funded Grant Programs

Iyore Osamwonyi, Assistant Consultant, and Phyllis Jacobson, Administrator, Professional Services Division, and Donna Glassman-Sommer, California Center on Teacher Careers, presented this item which provided an update on five state-funded grant programs administered by the Commission on Teacher Credentialing. This agenda item also presented the 2018 annual report on the California Classified School Employee Teacher Credentialing program as required by statute for Commission review and approval to transmit to the Legislature by January 1, 2019.

Serette Kaminski, California County Superintendents Educational Services Association, voiced a concern about assuring the field can access the funds to carry out robust successful programs that subsequently benefit classrooms across California.

**Doug Gephart, Association of California School Administers,** shared information regarding the outcome of the candidates who completed integrated teacher preparation programs.

**Jacob Guthrie, Los Angeles Unified School District,** provided an update regarding his district's funded grant program.

<u>Commissioner Zumot moved to approve the 2018 Annual Report on the California Classified School</u> <u>Employee Teacher Credentialing Program for transmittal to the Legislature.</u> <u>Commissioner Hinde</u> <u>seconded the motion. The motion carried without dissent</u>

#### 3F: Initial Employment of New Teachers in California

Marjorie Suckow, Consultant, Professional Services Division, presented this item which provided findings of a pilot study of the 2012-13 cohort of newly credentialed teachers and focused on initial employment rates between 2013 and 2018 for Commission discussion and feedback.

**Rigel Massaro, Public Advocates**, voiced appreciation for the data analysis and talked about the importance of making the data local and useable. She also requested the opportunity to work with Commission staff and other stakeholders to discuss what other analyses would be useful.

#### **Professional Practices Committee**

Committee Chair C. Michael Cooney convened the Professional Practices Committee.

#### 4A: Division of Professional Practices Workload Report

Gil Gonzalez, Manager, Division of Professional Practices, presented this item which provided a report on the Division of Professional Practices' current workload.

#### 4B: Committee of Credential Vacancies for Fiscal Year 2019-20

Ani Kindall, Staff Attorney, Division of Professional Practices, presented this item which reviewed the terms of the current members of the Committee of Credentials to declare vacancies for one school administrator member, one secondary teacher member and one public member.

<u>Commissioner Klatt moved to declare vacancies for one school administrator member, one</u> <u>secondary teacher member, and one public member. Commissioner Rodriguez seconded the</u> <u>motion. The motion carried without dissent.</u>

<u>Commissioner Hinde moved to open the vacancies to the public and reach out to any interested</u> <u>individuals currently in the alternate pool for each position to conduct interviews for those who</u> <u>submit an application.</u> Commissioner Hartwig seconded the motion. The motion carried without <u>dissent.</u>

#### 4C: Division of Professional Practices' and Committee of Credentials' Workload and Statutory Framework – Efficiency, Due Process, and Public Safety Implications

Mary Vixie Sandy, Executive Director, Commission on Teacher Credentialing, and Linda Schneider, Senior Assistant Attorney General, Office of the Attorney General, presented this item which addressed the existing challenges to efficiency, due process, and public safety, created by the increasing workload of the Division of Professional Practices and the Committee of Credentials, as well as the statutory framework currently governing the educator disciplinary process.

**Lori Easterling, California Teachers Association**, requested the Commission broaden the perspective of the regulatory work and not be limited to the recommendations suggested by Ms. Schneider. She also asked the Commission to work collaboratively with stakeholders in this process.

<u>Commissioner Klatt moved to authorize staff to engage with stakeholders and seek legislative</u> <u>solutions. Commissioner Rodriguez seconded the motion. The motion carried without dissent.</u>

#### Legislative Committee

Committee Chair Alicia Hinde convened the Legislative Committee.

#### 5A: Legislative Proposals

Joshua Speaks, Governmental Relations and Public Affairs Manager, Administrative Services Division, presented this item which provided possible sponsored legislative proposals for the 2019 legislative year for Commission consideration.

**Robert Williams, San Francisco State University,** asked staff a clarifying question regarding the required degree for Pupil Personnel Services Credentials.

Jenny Teresi, California County Superintendents Educational Services Association, requested the Commission to include stakeholders in the discussion on modernizing the assignment monitoring process.

<u>Commissioner Marks moved to approve the legislative proposal regarding the use of professional</u> <u>education baccalaureates</u>. Commissioner Allavie seconded the motion. The motion carried with <u>Commissioners Redmond and Zumot abstaining</u>.

<u>Commissioner Klatt moved to approve the legislative proposal to update the Education Code to</u> <u>reflect current terminology regarding world languages</u>. Commissioner Kung seconded the motion. <u>The motion carried with Commissioners Redmond and Zumot abstaining</u>.

<u>Commissioner Marks moved to approve the legislative proposal to update the clear credentialing</u> <u>requirements.</u> <u>Commissioner Rodriguez seconded the motion.</u> <u>The motion carried with</u> <u>Commissioners Redmond and Zumot abstaining.</u>
