Proposed Amendments to Title 5 of the California Code of Regulations Pertaining to the Single Induction Experience for New Teachers

Introduction

This rulemaking action proposes amendments to sections 80048.8, 80048.8.1, and 80413 of Title 5 of the California Code of Regulations (CCR) related to providing a single induction experience for new teachers and section 80523 to provide updates to sections of regulations related to these changes regarding how educators qualify for an extension of time to a credential, as approved by the Commission at the April 2018 meeting. The proposed regulations implement, interpret, and make specific Education Code (EC) §44225 pertaining to the requirements for the issuance of credentials.

The proposed regulations also include general cleanup and updating of regulations, deleting references to No Child Left Behind (NCLB) requirements now outdated with the signing of the Every Student Succeeds Act (ESSA) and references to fifth year and clear credential programs which have now transitioned to teacher induction programs. Also included is the addition of language that allows the use of a baccalaureate degree in professional education toward meeting the requirements for the Multiple Subject Teaching Credential, as provided in Education Code §44225(a)(1)(B).

Background

The Commission on Teacher Credentialing (Commission) conducted a public hearing on April 13, 2018 ([Agenda Item 2H](#)) and took action to approve the proposed amendments to Title 5 of the California Code of Regulations (CCR) pertaining to the single induction experience for new teachers. A 15-Day Notice was distributed on January 2, 2019 covering the period from January 3, 2019 to January 17, 2019, providing additional modifications to the regulation text pertaining to the proposed amendments to regulations to add clarity and consistency to the proposed changes, as requested by the Office of Administrative Law (OAL). The Commission received no public responses to the 15-Day Notice. Staff Recommendation

Staff recommends that the Commission adopt the proposed amendments to §80048.8, §80048.8.1, §80413, and §80523 to Title 5 of the CCR pertaining to the single induction experience for new teachers, including the modified text as required for submission to the OAL.

Commission Records Digitization Project - Approval of Contract Authority Over \$150,000 for Fiscal Year 2018-19

Background

The Commission is the state's licensing agency for all of California's public school educators. As such, the Agency has records of all teachers' current and past credentials dating back to the late 1800's. Given the long time span of these records, many of them are contained in formats that are no longer viable for searching or managing. Most records dating from the late 1800's to 1989 are currently housed in three Lektriever/microfiche modules that allow individuals to search for records on an individual basis by hand. These are then read using a microfiche machine. Others are housed on microfilm which also requires a manual search. The Commission estimates that there are approximately 1.3 million current records residing in these modules that are not in the Commission's Credentialing Automation System (CASE).

The Commission is required to keep a copy of all credential records for the life of the credential holder. Due to this requirement and the lack of feasibility for the Commission to truly know when an individual is deceased, millions of records are housed with the Commission. The records housed in the Lektrievers carry significant historical value in addition to being a requirement that the Commission maintain them and their accessibility. Converting all the credential records to a digital format will allow them to in an indexed, searchable format.

The state budget provided \$1,500,000 from the Commission's Teacher Credential Fund (TCF 0407) reserve account in the 2018-19 fiscal year to support a Request for Offers (RFO) to execute digitizing the Commission's records. The one-time funding will be used to (1) contract with a company to convert the records into a digital format and create a searchable database and (2) physically remove the current Lektriever modules (specialized storage units for microfiche) from the Commission's premises.

RFO Process

A RFO to secure a contractor to digitize the Commission's credential records is in development and scheduled to be released in mid-February. The RFO will be posted publicly on the Commission's website and following its release, the Commission will provide a period for potential applicants to send in questions related to the Request. The agency will then provide answers in the form of an FAQ document that will also be posted on the Commission's website and sent to potential bidders who filed a letter of intent to submit a proposal in response to the RFO.

For those proposals received by the submission deadline, the Commission will review each proposal first for technical compliance with the instructions and completeness of the proposal in responding to all required information. Proposals that meet the initial technical compliance

screening will then be read by a team of Commission staff members and rated according to the scoring criteria provided in the RFO. This process of staff review is in accordance with provisions of the State Contract Code. This item requests the Commission authorize the Executive Director to award and fully execute the contract in the amount not to exceed \$1,500,000 to the contractor that submits the winning proposal in order to begin work on digitizing the Commission's hard copy records.

Staff Recommendation

Staff recommends the Commission authorize the Executive Director to award and execute a contract, not to exceed \$1,500,000 for digitizing the Commission's credential data.

Program Approval

Introduction

This agenda item presents one elementary subject matter program submitted by an institution of higher education for approval.

Background

The Commission regularly receives recommendations for program approval from subject matter review panels. The content specific subject matter standards are closely aligned to the K-12 academic content standards. These subject matter programs are usually undergraduate courses of study completed before candidates begin teacher preparation programs. However, the two programs may be completed concurrently.

Subject Matter Program Review Procedures

Subject matter educators review the submitting institution's response to the preconditions. The preconditions are based on both state laws and Commission policies, and address minimum unit and content area requirements. The institution's responses to the Commission's subject matter program standards are reviewed by a team of two or more subject matter educators to determine if the program meets the program standards, including the subject matter requirements (SMRs). The SMRs are the content knowledge required to be covered in the program and are aligned to the K-12 content standards that the candidate will be expected to know. If the program does not meet the standards, the institution is given an explanation of the findings. The institution may then submit the additional information requested. Once reviewers determine that the program proposal provides a convincing and adequate body of evidence to meet the Commission's adopted subject matter program standards, the program is recommended to the Commission for approval. After subject matter program approval is granted by the Commission, the institution may admit candidates to the approved subject matter program. Graduates of a Commission approved subject matter preparation program meet the Commission's subject matter requirement and are not required to take the subject matter examination (California Subject Examinations for Teachers).

Summary Information on the Proposed Elementary Subject Matter Program

California State University, Northridge

California State University, Northridge's Elementary Subject Matter (ESM) program will provide Liberal Studies majors the required subject matter content to demonstrate mastery of ESM program requirements while they move through their Liberal Studies undergraduate major. The Liberal Studies major will provide candidates three different options (Pre-Credential, Integrated Teacher Education program-Freshman, and Integrated Teacher Education program-Junior) to complete their ESM program that is delivered through a collaborative and interdisciplinary partnership with the College of Science and Math; the College of Social and Behavioral

Sciences; the Mike Curb College of Arts, Media, and Communication; the College of Health and Human Development; the Michael D. Eisner College of Education; and the College of Humanities. The faculty and staff of all of the departments who offer courses in the program collaborate on all of the course content and syllabi to ensure that each of the ESM program standards is identified, practiced, and assessed leading to candidate mastery. Candidates will be carefully and regularly advised on how to complete the required curriculum by full-time professional academic advisors in the Liberal Studies program in the College of Humanities. The ESM program meets the minimum of 84 semester units and candidates choose a concentration of study in one of six content areas.

Staff Recommendation

Staff recommends that the Commission approve the Elementary Subject Matter Program at California State University, Northridge.
