Program Approval

Introduction

This agenda item presents one elementary subject matter program submitted by an institution of higher education for approval.

Background

The Commission regularly receives recommendations for program approval from subject matter review panels. The content specific subject matter standards are closely aligned to the K-12 academic content standards. These subject matter programs are usually undergraduate courses of study completed before candidates begin teacher preparation programs. However, the two programs may be completed concurrently.

Subject Matter Program Review Procedures

Subject matter educators review the submitting institution's response to the preconditions. The preconditions are based on both state laws and Commission policies, and address the minimum unit and content area requirements. The institution's responses to the Commission's subject matter program standards are reviewed by a team of two or more subject matter educators to determine if the program meets the program standards, including the subject matter requirements (SMRs). The SMRs are the content knowledge required to be covered in the program and are aligned to the K-12 content standards that the candidate will be expected to know. If the program does not meet the standards, the institution is given an explanation of the findings. The institution may then submit the additional information requested. Once reviewers determine that the program proposal provides a convincing and adequate body of evidence to meet the Commission's adopted subject matter program standards, the program is recommended to the Commission for approval. After subject matter program approval is granted by the Commission, the institution may admit candidates to the approved subject matter program. Graduates of a Commission approved subject matter preparation program meet the Commission's subject matter requirement and are not required to take the subject matter examination (California Subject Examinations for Teachers).

Summary Information on the Proposed Elementary Subject Matter Program

Dominican University of California

Dominican University of California's Elementary Subject Matter (ESM) Program is a 4-year interdisciplinary program directed by the Department of Education. The ESM program will be delivered through a collaborative partnership with the School of Health and Natural Sciences and the School of Liberal Arts and Education. Courses are drawn from multiple disciplines and provide candidates with a deep understanding of the subject matter they will teach: Mathematics; Science; Social Science; Reading, Language, & Literature; Visual & Performing Arts; Physical Education; and Human Development. Subject matter content faculty and

education faculty have a long history of collaboration to ensure candidates are engaged and proficient in the required subject matter throughout their four years at Dominican.

The ESM Program meets the minimum number of 84 semester units. A concentration in Science will be required of all candidates. This concentration is comprised of four courses with connected and integrated lab experiences. During their first semester in the program, candidates will be assigned an advisor who is a faculty member in the Department of Education. Candidates will meet with their advisers at least once per semester to ensure they complete the required coursework and participate fully in the Dominican Experience. Candidates will participate in integrative seminars each semester; the focus will be on integrating concurrent subject matter courses and fieldwork with best pedagogy practices through a social justice lens. The integrative seminars are cumulative with spiraling content, proficiencies, knowledge, and experiences. Dominican University of California's ESM Program will prepare candidates that are knowledgeable and competent in the content they will teach their future elementary school students.

Staff Recommendation

Staff recommends that the Commission approve the Elementary Subject Matter Program at Dominican University of California.
