Committee of Credentials Vacancies for FY 2020-21

Introduction

The Commission makes appointments to the Committee of Credentials (“Committee”) pursuant to Education Code section 44240. This item presents information concerning the expected vacancies for three positions on the Committee.

Background

The Committee is comprised of seven members appointed by the Commission and consists of one elementary teacher, one secondary teacher, one school board member, one school administrator employee, and three public representatives.

The Committee meets three days each month at the offices of the Division of Professional Practices in Sacramento. Members review allegations of educator misconduct to determine whether to recommend discipline.

The Commission’s Professional Practices Committee is responsible for informing “the Commission when vacancies occur or may be expected to occur on the Committee of Credentials.” (CTC Policy Manual §510). The CTC Policy Manual §511(a) states that “alternates may be selected if deemed qualified. Any alternate so selected will be placed in a pool of alternates and available to fill a vacancy in that position category should the need arise.”

The terms of Public Members Wade “Steve” Thorpe and Scotty “Cameron” Byrd, School Board Member Darrel Woo, and Elementary Teacher Dana Morellini expire on June 30, 2020. All four members are available for reappointment.
