Program Approval

Introduction

This agenda item presents one single subject matter program submitted by an institution of higher education for approval.

Background

The Commission regularly receives recommendations for program approval from subject matter review panels. The content specific subject matter standards are closely aligned to the K-12 academic content standards. These subject matter programs are usually undergraduate courses of study completed before candidates begin teacher preparation programs. However, the two programs may be completed concurrently.

Subject Matter Program Review Procedures

Subject matter educators review the submitting institution's response to the preconditions. The preconditions are based on both state laws and Commission policies, and address the minimum unit and content area requirements. The institution's responses to the Commission's subject matter program standards are reviewed by a team of two or more subject matter educators to determine if the program meets the program standards, including the Subject Matter Requirements (SMRs). The SMRs are the content knowledge required to be covered in the program and are aligned to the K-12 content standards that the candidate will be expected to know. If the program does not meet the standards, the institution is given an explanation of the findings. The institution may then submit the additional information requested. Once reviewers determine that the program proposal provides a convincing and adequate body of evidence to meet the Commission's adopted subject matter program standards, the program is recommended to the Commission for approval. After subject matter program approval is granted by the Commission, the institution may admit candidates to the approved subject matter program. Graduates of a Commission-approved subject matter preparation program meet the Commission's SMRs and are not required to take the subject matter examination (California Subject Examinations for Teachers).

Summary of Information on the Proposed Subject Matter Program

California Baptist University

California Baptist University's Single Subject Matter (SSM) program in Art will provide Fine Art majors the opportunity to demonstrate mastery of SSM program requirements while they move through their Fine Arts undergraduate major. The SSM program in Art will be delivered through a collaborative and interdisciplinary partnership with the College of Architecture, Visual Arts and Design. The faculty and staff of all of the departments who offer courses in the program collaborate on all of the course content and syllabi to ensure that each of the SSM program standards is identified, practiced, and assessed leading to student mastery. Candidates will be carefully and regularly advised on how to complete the required curriculum by full-time

advisors in the undergraduate advising department. The SSM program in Art meets the minimum of 36 semester units. The total units for the required core is 48 units. California Baptist University's SSM program in Art program ensures the quality of candidates' undergraduate experiences as they gain competence and content in order to deliver relevant 21st century learning in their future classrooms.
