This is my second whistleblower communication in response to your letter dated June 15, 2020.

Attached is responsive documents from my public records request from May 27, 2019. The data in question requested teachers referred to the CTC for discipline from May 30, 2014 through May 30th, 2019. As a citizen, I am compelled to report what I believe is improper governmental activity by state agencies and persons.

Therefore I would like these comments posted to the Committee of Credentials Report at the August 6th or August 7th CTC Board Meetings.

Needless to say the data with over **2,800 teachers** shows an average age of 49 and a standard deviation way over 13 for age 46 and over and over 21 standard deviations for over the age of 55. This strongly infers <u>age discrimination on a massive level</u>. Please request the state auditor investigate age, race and gender discrimination regarding the intake process for teachers pending disciplinary action by the CTC. Please respond to this letter by July 15, 2020. I would like to exhaust all administrative remedies before proceeding in this matter. Please review *Castaneda v. Partida, 430 U.S. 482 (1977)* for your reference.
