## **Update on the Work Relating to the Child Development Permit**

---

### **Introduction**

Applications for interested institutions of higher education that offer preparation for the child development permit to participate in the ECE Pilots under the Preschool Development Grant-Renewal (PDG-R) closed on February 1, 2021 for the first grant program year. As this closing date was later than the agenda posting date of January 29, 2021 for the February 11-12, 2021 Commission meeting, additional applications for participation in the ECE Pilots have been received between January 29 and February 1, 2021.

### **Background**

This agenda insert provides an updated list of all institutions of higher education that have applied and been accepted to participate in the ECE pilots being implemented under the PDG-R grant for the application period ending on February 1, 2021. A total of 51 institutions are on the updated list of ECE Pilots participants.

Additional interested institutions of higher education offering preparation for the child development permit may continue to apply for and be accepted into the ECE pilots under the PDG-R grant at any time. For reporting purposes only, institutions applying and being accepted into the ECE Pilots after February 1, 2021 will be reported as PDG-R grant year 2 participating institutions, along with the grant year 1 institutions continuing their participation into grant year 2.
