# Program Approval

## **Introduction**

This agenda item presents two elementary subject matter programs and two single subject matter programs submitted by institutions of higher education for approval.

## **Background**

The Commission regularly receives recommendations for program approval from subject matter review panels. The content specific subject matter standards are closely aligned to the K-12 academic content standards. These subject matter programs are usually undergraduate courses of study completed before candidates begin teacher preparation programs. However, the two programs may be completed concurrently.

## **Subject Matter Program Review Procedures**

Subject matter educators review the submitting institution's response to the preconditions. The preconditions are based on both state laws and Commission policies and address the minimum unit and content area requirements. The institution's responses to the Commission's subject matter program standards are reviewed by a team of two or more subject matter educators to determine if the program meets the program standards, including the Subject Matter Requirements (SMRs). The SMRs are the content knowledge required to be covered in the program and are aligned to the K-12 content standards that the candidate will be expected to know. If the program does not meet the standards, the institution is given an explanation of the findings. The institution may then submit the additional information requested. Once reviewers determine that the program proposal provides a convincing and adequate body of evidence to meet the Commission's adopted subject matter program standards, the program is recommended to the Commission for approval. After subject matter program approval is granted by the Commission, the institution may admit candidates to the approved subject matter program. Graduates of a Commission-approved subject matter preparation program meet the Commission's SMRs and are not required to take the subject matter examination (California Subject Examinations for Teachers).

## **Summary of Information on the Proposed Subject Matter Programs**

### **California State University, Fullerton**

California State University, Fullerton's Elementary Subject Matter (ESM) program will provide pathways in Child and Adolescent Studies: Elementary School Settings (CHAS) and Liberal Studies (LBST). Each pathway will provide candidates the opportunity to demonstrate mastery of ESM requirements while earning their bachelor's degree. The pathway includes major requirements, general education requirements, ESM requirements and credential program prerequisites (121 units completed in the LBST major and 123 units completed in the CHAS major). Candidates will be regularly advised on how to complete the ESM pathway by full-time student services professionals in the Center for Careers in Teaching and will also receive course

advising from academic advisors in the LBST or CHAS departments. The pathway enables candidates to satisfy the ESM program standards while completing general education and major requirements and ensures students receive the exposure and time to develop expertise in the subject matter prior to entering the teacher preparation program.

### **Fresno Pacific University**

Fresno Pacific's Liberal Arts Elementary Subject Matter (ESM) program is a baccalaureate program designed to provide candidates solid foundational knowledge in the Elementary Subject Matter areas outlined by the program standards. Through built-in formative assessments, summative assessments and carefully designed coursework candidates will have the opportunity to master the ESM requirements as they progress through the program course sequence. Coursework and curriculum in this interdisciplinary program have been developed by lead faculty housed in various schools within the university including, the School of Education; School of Humanities, Religion and Social Science; and the School of Natural Sciences. This diverse group of faculty are guided by the Liberal Arts program director who oversees each core program course and overall program quality. Core program courses have been updated to align with ESM domain requirements. The program also includes a 12-unit concentration in science. Liberal Arts candidates are advised by a team of regional advisors and outreach staff who assist in navigating candidates through the program sequence and prepare candidates for next steps in their career path.

### **University of the Pacific**

The Social Science major at University of the Pacific will provide candidates the opportunity to demonstrate mastery of the Social Science Subject Matter Program (SSSMP) requirements as they move through the Social Sciences undergraduate major. The SSSMP will be delivered through a collaborative and interdisciplinary partnership with the Social Science Division within the College of the Pacific. The faculty and staff of all of the departments that offer classes for the Social Sciences major (History, Economics, School of International Studies, Sociology, Political Science) collaborated on course content to ensure that each of the SSSMP standards is identified, practiced, and assessed leading to student mastery. The SSSMP meets the requirement of 30 semester units of core coursework in history and social science subjects and the minimum of 15 semester units that extend the study of social sciences. The major requires a minimum of 45 semester units total, distributed as follows. History: eight courses that include one introductory course, one course in California history, two courses in World History, two courses in U.S. history, one course in the history of a non-U.S. country or region, and one course with a world geography component. Political Science: two courses that include one course in U.S. national government and one course that deals with either a) comparative politics and government, b) politics and government of a foreign country, or c) international relations. Sociology: two courses which include one course that deals with the basic concepts of Sociology and one course that deals with either a) structural analysis, b) social psychological analysis, or c) cultural anthropology. Economics: one introductory course that includes microeconomics and macroeconomics. University of the Pacific's major in the social sciences offers a SSSMP that ensures the quality of candidates' undergraduate experiences as they gain

social science competence and content in order to deliver relevant 21st century learning in their future classrooms.

### **Biola University**

Biola University's Single Subject Matter (SSM) program in Mathematics will provide undergraduate candidates the opportunity to demonstrate mastery of SSM program requirements while they work toward completing their B.S. degree in Mathematics with an emphasis in Secondary Education. The SSM program will be delivered through a collaborative partnership between the Department of Mathematics and Computer Science and the School of Education. The faculty and staff of both departments collaborated on course content, the structure of the program, program learning outcomes, and candidate progress to ensure that each of the SSM program standards is identified, practiced, and assessed leading to candidate mastery. Candidates will be assigned an academic advisor from the Math and Computer Science Department, as well as an advisor from the School of Education. Advisors will meet with candidates regularly to guide them through the process of completing the required curriculum and staying on track for graduation.

The SSM program in Mathematics at Biola University requires 64 semester units, which include a) 32 semester units of core mathematics coursework that is directly related to the K-12 state-adopted academic content standards, b) a minimum of 15 semester units of coursework that supplement and deepen the essential core of the program, and c) 17 units of education-focused courses through the School of Education. Biola's SSM program is designed to methodically facilitate the development of prospective teachers in their growth as mathematicians. Further, the program prepares candidates to facilitate the learning of mathematical concepts, methodology, and skills in a way that is understood, appreciated, and utilized by all of their future students.
