# Modifications to Proposed Amendments to Title 5 of the California Code of Regulations Pertaining to Pupil Personnel Services Credentials and Program Standards

---

## Introduction

This addition to the Pupil Personnel Services rulemaking action proposes the following:

- Repeal section 80632.5. This section contains the outdated Pupil Personnel Services (PPS) program standards and was unintentionally omitted from the text submitted with the original 45-day notice.

## Background

In [April 2019](#) the Commission adopted the updated Pupil Personnel Services (PPS) preconditions, program standards, and performance expectations and in [April 2021](#) the proposed updated regulations were approved by the Commission for submission to the Office of Administrative Law. When the regulatory packet was being prepared for submission, staff noticed that section 80632.5 pertaining to Child Welfare and Attendance standards was unintentionally omitted from the initial 45-day notice and text. A 15-day notice was posted on July 2, 2021 to correct the error. The public comment period closed at the end of the day on July 19, 2021. No comments were received.

## Summary of Proposed Modifications

Below is a summary of the proposed modifications in this regulation proposal. The proposed regulation text is available in [Appendix A](#). The PPS standards are available on the [Commission's standards webpage](#).

### *Proposed Repeal of Section 80632.5*

In the original 45-day notice for this regulatory packet the language in the notice included the repeal of section 80632.5, however that section was unintentionally omitted from the noticed proposed text. Text proposed to be deleted is in [Appendix A](#). This action will repeal the outdated Child Welfare and Attendance educator preparation program standards. Child Welfare and Attendance preparation is now embedded within each set of the new standards proposed in section 80614 which the Commission adopted at the [April 2021](#) meeting. Candidates in a Pupil Personnel Services Program may elect to complete the additional requirements to earn both their School Psychology, School Counseling, or School Social Work credential and the Child Welfare and Attendance authorization.

## Staff Recommendation

Staff recommends that the Commission adopt the proposed modifications to the regulations.

## Next Steps

If approved by the Commission, staff will complete the rulemaking packet for submission to the Office of Administrative Law.

## Program Approval

### **Introduction**

This agenda item presents one Elementary Subject Matter program and two Single Subject Matter programs submitted by institutions of higher education for approval.

### **Background**

The Commission regularly receives recommendations for program approval from subject matter review panels. The content specific subject matter standards are closely aligned to the K-12 academic content standards. These subject matter programs are usually undergraduate courses of study completed before candidates begin teacher preparation programs. However, the two programs may be completed concurrently.

### **Subject Matter Program Review Procedures**

Subject matter educators review the submitting institution's response to the preconditions. The preconditions are based on both state laws and Commission policies and address the minimum unit and content area requirements. The institution's responses to the Commission's subject matter program standards are reviewed by a team of two or more subject matter educators to determine if the program meets the program standards, including the Subject Matter Requirements (SMRs). The SMRs are the content knowledge required to be covered in the program and are aligned to the K-12 content standards that the candidate will be expected to know. If the program does not meet the standards, the institution is given an explanation of the findings. The institution may then submit the additional information requested. Once reviewers determine that the program proposal provides a convincing and adequate body of evidence to meet the Commission's adopted subject matter program standards, the program is recommended to the Commission for approval. After subject matter program approval is granted by the Commission, the institution may admit candidates to the approved subject matter program. Graduates of a Commission-approved subject matter preparation program meet the Commission's SMRs and are not required to take the subject matter examination (California Subject Examinations for Teachers).

### **Summary of Information on the Proposed Elementary Subject Matter Program**

#### **Humboldt State University**

The Elementary Subject Matter (ESM) competency program at Humboldt State University (HSU) is an integral component of the Liberal Studies major. The Liberal Studies major includes two Bachelor of Arts concentrations and two BA + Credential Integrated Teacher Education concentrations (Multiple Subject and Education Specialist). Each concentration is designed to prepare candidates to be innovative, responsive, and professional educators. These four concentrations are housed in two departments within the College of Professional Studies at HSU: Child Development and School of Education.



The four concentrations in the Liberal Studies major share a core set of courses through which students demonstrate ESM and meet the minimum of 84 semester units. ESM program coursework begins with general education classes and gradually transitions to major specific courses that are designed to improve, broaden and deepen facility with, appreciation of, understanding and development of the knowledge, skills and dispositions that are of most benefit to future elementary educators. The ESM team worked closely with departments across HSU to identify courses and design the ESM program of study. Throughout this process, the ESM team has deepened the collaborative relationships within the Child Development and School of Education departments through which HSU will provide ongoing oversight and support of the ESM program within the Liberal Studies major.

### **Summary of Information on the Proposed Single Subject Matter Programs**

#### **San Francisco State University**

The San Francisco State University subject matter program for Social Science will support students to develop robust forms of subject matter knowledge for teaching History-Social Studies and Ethnic Studies across grade levels. The program will feature multiple pathways and options for students to complete courses comprehensively aligned with the content, concepts and skills detailed in the California History-Social Science Framework. In particular, students will complete 30 course units drawn largely from the Department of History along with courses in economics, political science, and geography. Additionally, students will have multiple pathways for completing 36 course units drawn largely from the College of Ethnic Studies, along with additional courses in the History Department. This interdisciplinary design combines choice and flexibility with rigor, and breadth with depth. It will support teachers to enter the profession with subject matter and pedagogical knowledge bases that are wide ranging, critical, and relevant. San Francisco State University's College of Ethnic Studies, the History Department, and Graduate College of Education will create a Social Science Waiver Board to oversee processes, assessment metrics, and program review and to recruit faculty for advising students. The program will be housed in the College of Ethnic Studies, with a faculty advisor assigned as Social Science Waiver Coordinator. Additionally, the History Department will designate a Social Science Waiver Counselor to work with the program coordinator.

#### **Sonoma State University**

Sonoma State University's Foundational Level General Science (FLGS) program will provide students with the opportunity to demonstrate mastery of FLGS subject matter requirements and work toward being qualified to teach general science at the middle or high school level. The FLGS program will consist of 37-semester units. The program meets the 32 units discipline requirement throughout coursework that spans Biology, Chemistry, Geoscience, and Physics. The program also includes a three-unit Maker course in which students learn about design principles, practices, and applications. Finally, through a three-unit science teaching/learning fieldwork and seminar course, students connect what they have learned about the sciences to what it will be like to teach science. The FLGS program is a collaboration between the School of Education and the School of Science and Technology. Faculty primarily in the School of Science and Technology have developed the courses and will periodically meet to ensure identified

FLGS standards are introduced, practiced, and assessed in ways that lead to student mastery. These courses have also been carefully aligned to a teaching concentration in the school's new B.A. in Physics Science degree program. A School of Education faculty member will primarily oversee candidate advising and program progress while working with the School of Education unit to ensure students meet all program requirements. The FLGS courses and program as a whole will ensure that the students understand foundational ideas in science and how scientists and engineers construct and apply knowledge about the natural world. The program will also contribute to Sonoma State University's mission by preparing prospective teachers to apply their understanding of science when learning how to teach in schools with culturally, linguistically, and socioeconomically diverse students.
