Ad Hoc Committee

Committee Chair Marquita Grenot-Scheyer convened the Ad Hoc Committee at 10:02 a.m.

1A: Interview and Recommendation of a Member and Alternate to the School Board Member Position for the Committee of Credentials

Committee Chair Grenot-Scheyer noticed the public that De'shawn Woolridge withdrew his application for the position. The Committee interviewed applicant Michele Perrault.

Commission Action

Commissioner Simmons moved to recommend Michele Perrault be appointed to serve as the school board member on the Committee of Credentials. Commissioner Klatt seconded the motion. The motion carried without dissent.

Adjournment

There being no further business, Committee Chair Grenot-Scheyer adjourned the Ad Hoc Committee at 10:20 a.m.

General Session

Chair Tine Sloan convened the General Session of the Commission at 1:36 p.m. Roll call was taken, and the Pledge of Allegiance was recited.

Chair Sloan welcomed Danette Brown as a new member of the Commission.

2A: Approval of the April 2022 Minutes

Commissioner Gross moved approval of the April 2022 Ad Hoc Committee meeting minutes. Commissioner Simmons seconded the motion. The motion carried without dissent.

Commissioner Martinez moved approval of the April 2022 Commission meeting minutes. Commissioner Davis seconded the motion. The motion carried without dissent.

2B: Approval of the June 2022 Agenda

Commissioner Klatt moved approval of the June 2022 Agenda with agenda inserts for items 2C, 3A, 3D, and 5B, and a handout for item 3C. Commissioner Gross seconded the motion. The motion carried without dissent.

2C: Approval of the June 2022 Consent Calendar

Commissioner Klatt moved approval of the June 2022 Consent Calendar with an amendment to withdraw items 51. Robert Jacobo, Jr., 56, Thomas Lauffenberger, 62. Gregory McKinsey, 65. Jonathan Mesisca, and 78. Regina Poudel to be reviewed during Closed Session. Commissioner Martinez seconded the motion. The motion carried with Commissioner Jackson recusing herself from item 5. Stephanie Baker.

2D: Chair's Report

Chair Sloan spoke about graduations at her university. She expressed her feelings regarding the violence happening in schools and the important responsibility of protecting our students and teachers. She also spoke briefly about issues that would be presented during the June Commission meeting.

2E: Executive Director's Report

Executive Director Sandy expressed her appreciation for Chair Sloan's comments. She also spoke about her interactions with new teachers as they enter into the profession. Executive Director Sandy introduced Lynn Larsen, a new consultant with the Professional Services Division and notified the public that the Commission is accepting applications for the Educator Preparation Student Liaison position.

2F: Commission Member Reports

Commissioner Browne shared her excitement about participating in live outdoor commencements on campus.

Commissioner Grenot-Scheyer shared a poem “Who Will Clean Out The Desks’ — A crowdsourced poem in praise of teachers” that was on NPR in May 2022.

2G: Liaison Reports

Haydee Rodriguez, State Board of Education Liaison, reported on her attendance at the State Board’s May 2022 meeting.

Educator Preparation Committee

Committee Chair Monica Martinez convened the Educator Preparation Committee.

3C: Report to the Legislature on the Implementation of Senate Bill 488 Teacher Credentialing – Reading Instruction

Nancy Brynelson and Roxann Purdue, Consultants, Professional Services Division, presented this item which provided information on Senate Bill 488 (Chap. 678, Stats. 2021) that requires the Commission to update its standards for the preparation of teacher candidates for reading and literacy instruction, review teacher preparation programs’ progress in meeting updated standards, and develop a new literacy performance assessment to replace the current Reading Instruction Competence Assessment (RICA) by 2025. The item presented the first annual report to the Legislature on the progress in implementing these requirements, including information on how constituencies were engaged in the process as called for in the statute.

Manuel Buenrostro, Californians Together, thanked the Commission and the staff for incorporating public feedback for the program standards and for providing additional guidance on designated and integrated ELD. He also offered their continued support for a balanced literacy approach that incorporates all of the language domains that are critical for multilingual students and English learners as the Commission continues to update the Literacy Teaching Performance Expectations and program standards.

Rex, spoke about the importance of getting feedback from the public and stakeholders especially parents, teachers and site leaders while moving forward on implementing SB 488.

Anita Flemington, AICCU-ED, submitted a written comment which raised concerns regarding the RICA, the testing company, and the dyslexia standards.

Commission Action

Chair Sloan moved to approve the Report to the Legislature on Senate Bill 488 Teacher Credentialing – Reading Instruction for transmittal to the Legislature with the updated timeline to include May 10, 2022 as the first meeting date for work relating to the implementation of SB 488. Commissioner Gross seconded the motion. The motion carried without dissent.

3A: Proposed Authorization Statement and Credential Requirements for the PK-3 Early Childhood Education Specialist Credential

Phyllis Jacobson, Administrator, Professional Services Division, Mary Vixie Sandy, Executive Director, and Renee Marshall, California Community Colleges Teacher Preparation Programs, presented this item which provided for potential adoption by the Commission the proposed Authorization Statement and Credential Requirements for transitioning the current Early Childhood Education (ECE) Specialist Credential into the PK-3 ECE Specialist Instruction Credential. The item discussed pathways and options for candidates to complete the proposed credential requirements and reported on additional public participation and input activities since the April 2022 Commission meeting that helped inform these recommendations. This work is responsive to direction provided by the state's Master Plan for Early Learning and Care, extensive input from the field, and the need for additional ECE teachers to support the statewide UPK implementation as called for in the Governor's budget.

Deborah Stipek, ECE Credentialing Workgroup Member, and Sarah Neville-Morgan, California Department of Education, assisted staff in presenting this item.

Commission Action

Commissioner Simmons moved to endorse in principle the following proposed authorization statement for the PK-3 ECE Specialist Credential:

- This credential authorizes the holder to teach all subjects in a self-contained general education classroom setting and, as a self-contained classroom teacher, to team teach or to regroup students across classrooms, in preschool through grade three.

Commissioner Gross seconded the motion. The motion carried without dissent.

The Commission made the following actions regarding the proposed pathways and options for meeting the credential requirements:

Commissioner Simmons moved to endorse the following options for PK-3 ECE Subject Matter knowledge:

- **Option A:** Hold a bachelor's or higher degree with a Child Development (CD) or Early Childhood Education (ECE) major
- **Option B:** Complete 24 units of ECE/CD coursework offered through a regionally accredited 2- or 4-year institution of higher education. (Note: Can be met by coursework developed through the Curriculum Alignment Project (CAP 8) or similar coursework that addresses child development and early childhood pedagogy by a four-year institution)

Commissioner Heredia seconded the motion. The motion carried without dissent.

Chair Sloan moved to endorse in concept the following requirements for PK-3 ECE Teacher Preparation with the provision to include specific language around meeting the requirements of SB 488 when the new Literacy TPEs and Program Standard are available:

Complete a Commission-approved teacher preparation program model that includes:

- 1) PK-3 aligned coursework focused on curriculum standards and frameworks pedagogy and assessment, developmentally appropriate pedagogy, PK-3 aligned, math and literacy and language development (including but not limited to the teaching of reading), early identification of special needs, including dyslexia, and inclusion (e.g., mathematics, English Language Arts, including the teaching of reading, dyslexia, and English Language Development, History/Social Science, Science), state frameworks, pedagogy and assessment
- 2) 600 hours of supervised clinical practice distributed across PK/TK and K-3 as specified
- 3) Passage of an applicable Teaching Performance Assessment
- 4) Passage of the RICA or a Commission approved literacy performance assessment aligned with the requirements outlined in Education Code section 44320.3.

Program Pathways include:

- Integrated undergraduate preparation programs
- Combined community college, baccalaureate, and/or post-baccalaureate programs (e.g., 2+2; 2+2+1, 4+1)
- Fifth-year post baccalaureate preparation programs
- Teacher Residency programs
- Intern Preparation programs (University and/or District based programs)
- Registered apprenticeships (when available)

Commissioner de la Torre seconded the motion. The motion carried without dissent.

The Commission directed staff to get more feedback from other sources and to work on clarifying language/details regarding granting equivalence for prior experience, the options for expedited pathways for experienced Child Development Teachers to earn the PK-3 ECE Specialist Credential and the additional potential option of establishing a limited authorization for Child Development Permit teachers and Head Start teachers.

The Commission discussed the option of an expedited pathway for multiple subject credential holders and indicated verbal agreement with this option.

Commissioner Simmons moved that with regard to the RICA requirement the new PK-3 ECE Specialist credential should have all of the same options and limitations as the current multiple subject credential. Commissioner Gross seconded the motion. The motion carried without dissent.

Thursday, June 16, 2022

General Session

Chair Tine Sloan reconvened the General Session of the Commission at 8:33 a.m. and roll call was taken.

Certification Committee

Committee Chair David Simmons convened the Certification Committee.

4A: Report to the Legislature on Credentialing Related to Noncore Teaching Assignments Pursuant to Assembly Bill 1505

Erin Skubal, Director, and Erin Henderson, Assignment Program Manager, Certification Division, presented this item which provided a comprehensive study to examine whether existing certificates, permits, or other documents adequately address the needs for noncore, noncollege preparatory courses in all schools in response to Education Code section 47605.4(b) which requires the Commission to report to the Legislature by June 30, 2022.

Gina Plate, California Charter Schools Association, submitted a letter in support of the report to the Legislature as defined in AB 1505.

Commission Action

Commissioner Martinez moved to approve the Assembly Bill 1505 Report with the amendment to strike the last paragraph on page 4A-12 of the report for transmittal to the Legislature. Commissioner Davis seconded the motion. The motion carried without dissent.

Educator Preparation Committee

Committee Chair Monica Martinez reconvened the Educator Preparation Committee.

3D: Study Session on the Role and Function of Performance Assessment in Educator Preparation and Credentialing

Mary Vixie Sandy, Executive Director, presented this item which brought two invited panels of experts and practitioners to the table to discuss the history, current research, and use of performance assessments in the field of education and how these types of complex measures support programs and candidates to reflect on emerging practice and prepare educators to begin professional practice.

3G: Initial Institutional Approval – Stage II: Eligibility Requirements for Gateway High School

Michele Williams-George, Consultant, Professional Services Division, presented this item which provided, as part of the Initial Institutional Approval process, Gateway High School's responses to the Eligibility Requirements for consideration and possible approval by the Commission.

Aaron Watson and Donna Scarlett, Gateway High School, assisted staff in presenting this item.

Commission Action

Commissioner Klatt moved to grant eligibility to Gateway High School and move forward to Stage III of the Initial Institutional Approval process. Commissioner Simmons seconded the motion. The motion carried without dissent.

3F: Initial Institutional Approval – Stage III: Consideration of Provisional Approval for Santa Maria Bonita School District

Michele Williams-George, Consultant, Professional Services Division, presented this item which provided, as part of the Initial Institutional Approval process, Santa Maria Bonita School District's responses to the Common Standards and Program Preconditions for consideration and possible Provisional Approval by the Commission.

Shelli Hart, Santa Maria Bonita School District, assisted staff in presenting this item.

Commission Action

Commissioner Klatt moved to grant Provisional Approval to Santa Maria Bonita School District and set the Provisional Approval period to be three years. Commissioner Davis seconded the motion. The motion carried without dissent.

3H: Initial Institutional Approval – Stage II: Eligibility Requirements for The Charter School of San Diego

Hart Boyd, Consultant, Professional Services Division, presented this item which provided, as part of the Initial Institutional Approval process, The Charter School of San Diego's responses to the Eligibility Requirements for consideration and possible approval by the Commission.

Cathryn Rambo and Veronica Radtke, The Charter School of San Diego, assisted staff in presenting this item.

Commission Action

Commissioner Klatt moved to grant eligibility to The Charter School of San Diego and move forward to Stage III of the Initial Institutional Approval process. Commissioner de la Torre seconded the motion. The motion carried without dissent.

3E: Update on the Development of the CalTPA for Education Specialist Mild to Moderate Support Needs and Extensive Support Needs Credential Areas of Emphasis and Adoption of Passing Score Standards for these Performance Assessments

Commissioner Bonnie Klatt stepped in to chair the Educator Preparation Committee due to Commissioner Martinez's absence.

Amy Reising, Chief Deputy Director, James Webb, Consultant, Professional Services Division, Heather Klesch, Vice President, Educator Solutions for Licensing and Learning, and Jon Twing, Senior Vice President for Psychometrics and Testing Services, Evaluation Systems group of Pearson, presented this item which provided (a) an update on the development of the Commission's Education Specialist CalTPA for the Mild to Moderate Support Needs (MMSN) and Extensive Support Needs (ESN) credential areas of emphasis, a brief review of field test outcomes and a summary of these findings; (b) foundational information about the standard setting process and recommendations for passing score standards; and (c) information and timeline describing how the Commission and its technical contractor Evaluation Systems group of Pearson will support MMSN and ESN programs to prepare for the first year of operational administration, 2022-23.

Commission Action

Commissioner Davis moved to adopt the Education Specialist Mild to Moderate Support Needs and Extensive Support Needs CalTPAs for operational administration beginning October 2022. Commissioner Jackson seconded the motion. The motion carried without dissent.

Commissioner Davis moved to establish the following passing standards for initial implementation of the Education Specialist Mild to Moderate Support Needs CalTPA:

- MMSN Cycle 1: Passing standard of 19 points with one score of 1 allowed and apply a Standard Error of Measurement of -1.0, resulting in a passing score of 17.
- MMSN Cycle 2: Passing standard of 21 points with one score of 1 allowed and apply a Standard Error of Measurement of -1.0, resulting in a passing score of 19. Commissioner Jackson seconded the motion. The motion carried without dissent.

Commissioner de la Torre seconded the motion. The motion carried without dissent.

Commissioner de la Torre moved to establish the following passing standards for initial implementation of the Education Specialist Extensive Support Needs CalTPA:

- ESN Cycle 1: Passing standard of 19 points and apply a Standard Error of Measurement of -1.5, resulting in a passing score of 15.
- ESN Cycle 2: Passing standard of 20 points and apply a Standard Error of Measurement of -1.5, resulting in a passing score of 17.

Commissioner Davis seconded the motion. The motion carried without dissent.

Commissioner Davis moved to direct staff to collect and study two years of data to understand how candidates are performing and to conduct a second standard setting review/study in spring 2024. Commissioner de la Torre seconded the motion. The motion carried without dissent.

3B: Proposed Adoption of Teaching Performance Expectations and Program Standards for the PK-3 Early Childhood Education Specialist Credential

Phyllis Jacobson, Administrator, Professional Services Division, and Amy Reising, Chief Deputy Director, presented this item which provided for potential adoption by the Commission the Teaching Performance Expectations for the proposed PK-3 Early Childhood Education (ECE) Specialist Instruction Credential and PK-3 ECE Specialist Instruction Credential Preparation Program Standards. This work is responsive both to the direction provided by the state's Master Plan for Early Learning and Care and to the need for additional ECE teachers to support the statewide Universal Transitional Kindergarten implementation as called for in the Governor's budget.

Commission Action

Chair Sloan moved to endorse the proposed Teaching Performance Expectations and Preparation Program Standards in concept for the PK-3 ECE Specialist Credential and directed staff to bring the revisions and draft regulations back to the August 2022 Commission meeting for consideration, including the new Literacy TPEs and Program Standard pursuant to SB 488. Commissioner de la Torre seconded the motion. The motion carried without dissent.

5A: Status of Legislation

Jonathon Howard, Government Relations & Public Affairs Manager, Administrative Services Division, presented this item which provided the status of those legislative measures of interest to the Commission and addressed questions regarding any other legislation identified by Commissioners.

5B: Analysis of Bills

Jonathon Howard, Government Relations & Public Affairs Manager, Administrative Services Division, presented analyses of SB 1487 (Rubio) and AB 2694 (Rubio), which impact the Commission's work. The analyses summarized current law, described the bills' provisions, and estimated their costs.

Commission Action

Commissioner Davis moved to support SB 1487 and directed staff to continue conversations with the author and their staff to amend the bill as necessary. Commissioner Hartwig seconded the motion. The motion carried without dissent.

Commissioner Simmons moved to support AB 2694 with an amendment that all induction programs have access to this grant. Commissioner Heredia seconded the motion. The motion carried without dissent.

Educator Preparation Committee

Commissioner Klatt reconvened the Educator Preparation Committee.

3I: Proposed Adoption of Regulations Regarding Options for Meeting the Subject Matter Competence Requirement

David DeGuire, Director, Professional Services Division, presented this item which provided draft proposed regulations to clarify and standardize implementation of options for meeting the subject matter competence requirement in Education Code sections 44259 and 44310 that were created by AB 130 (Chap. 44, Stats. 2021).

Commissioner Davis moved to approve the proposed regulations language and direct staff to submit a permanent regulation change package to the Office of Administrative Law. Commissioner Simmons seconded the motion. The motion carried without dissent.

3J: Consideration of Continued Suspension of Preconditions Requiring Demonstration of Subject Matter Competence Prior to Daily Whole Class Instruction

Cheryl Hickey, Administrator, and Jake Shuler, Consultant, Professional Services Division, presented this item which provided a proposal for the Commission to consider extending for

one additional academic year the suspension of the preconditions requirement that student teachers must satisfy subject matter competence prior to daily whole class instruction.

Commission Action

Commissioner Simmons moved to continue the suspension of the precondition requiring demonstration of subject matter competence prior to daily whole class instruction for non-intern candidates enrolled in the 2022-23 academic year. Commissioner Heredia seconded the motion. The motion carried without dissent.
