# Program Approval

## Introduction

This agenda item presents one Single Subject Matter program submitted by an institution of higher education for approval.

## Background

The Commission regularly receives recommendations for program approval from subject matter review panels. The content specific subject matter standards are closely aligned to the K-12 academic content standards. These subject matter programs are usually undergraduate courses of study completed before candidates begin teacher preparation programs. However, the two programs may be completed concurrently.

## Subject Matter Program Review Procedures

Subject matter educators review the submitting institution's response to the preconditions. The preconditions are based on both state laws and Commission policies and address the minimum unit and content area requirements. The institution's responses to the Commission's subject matter program standards are reviewed by a team of two or more subject matter educators to determine if the program meets the program standards, including the Subject Matter Requirements (SMRs). The SMRs are the content knowledge required to be covered in the program and are aligned to the K-12 content standards that the candidate will be expected to know. If the program does not meet the standards, the institution is given an explanation of the findings. The institution may then submit the additional information requested. Once reviewers determine that the program proposal provides a convincing and adequate body of evidence to meet the Commission's adopted subject matter program standards, the program is recommended to the Commission for approval. After subject matter program approval is granted by the Commission, the institution may admit candidates to the approved subject matter program. Graduates of a Commission-approved subject matter preparation program meet the Commission's SMRs and are not required to take the subject matter examination (California Subject Examinations for Teachers).

## Summary of Information on the Proposed Single Subject Matter Program

### California State University, Northridge

The California State University Northridge (CSUN) subject matter program for Foundational Level General Science (FLGS) will have seven pathways for students majoring in Biology (BA or BS), Biochemistry (BS), Chemistry (BA and BS), Geology (BS) and Physics (BA or BS) to pursue the course work needed to obtain a FLGS waiver. The FLGS program will consist of 32 units. The pathways are built off the courses that the students will already be taking for their undergraduate major with extra courses in the science content that is not part of their major's courses. A course matrix serves as a useful guide to indicate which courses students will need to take in order to have the breadth of science content knowledge necessary for a secondary science credential. The program will be housed in the College of Science and Mathematics but will collaborate with the Michael D. Eisner College of Education at CSUN to ensure students are

on the right path to graduate in a timely manner and be ready to enter a secondary credential program upon completion of their undergraduate science degree. Academic advisors in each of the major pathways listed above will collaborate with the campus' waiver coordinators to recruit students and ensure their completion. The waiver will help shorten the timeline and provide many more potential science teachers into the pipeline helping alleviate the immediate need for science teachers in the state of California.

**Staff Recommendation**

Staff recommends that the Commission approve the subject matter program shown below:

# Replacing the Term “Stakeholder” in Commission-adopted Standards

---

## Introduction

This agenda item proposes updates to Commission-adopted standards for the purpose of replacing the term “stakeholder” throughout with acceptable terminology. Since the language of the standards is adopted by the Commission, the Commission must take action to approve and adopt these changes. Staff proposes revisions to the Common Standards for Commission approval and adoption and requests Commission approval to update all other standards and glossaries similarly where this language appears.

## Background

The Commission’s [Common Standards](#) set forth the expectations for institutional and unit wide support for credential programs and are a critically important aspect of the Commission’s accountability system. It has been brought to the attention of staff that the term “stakeholder” carries derogatory and offensive meaning to some communities including, but not limited to, Native Americans and Indigenous Tribes. Staff therefore proposes replacing this term with appropriate language in the two sentences in the Commission’s adopted Common Standards where it appears. The two sentences that currently contain the word “stakeholders” is in Common Standards 1 and Common Standard 4. The language proposed for elimination is included below in strikethrough while the revised language proposed to be added is underlined:

### ***Common Standard 1: Institutional Infrastructure to Support Educator Preparation***

*The institution actively involves faculty, instructional personnel, and relevant ~~stakeholders~~ constituencies in the organization, coordination, and decision making for all educator preparation programs.*

### ***Common Standard 4: Continuous Improvement***

*The continuous improvement process includes multiple sources of data including 1) the extent to which candidates are prepared to enter professional practice; and 2) feedback from key ~~stakeholders~~ constituents such as employers and community partners about the quality of the preparation.*

## Staff Recommendation

Staff recommends that the Commission adopt the revised language for the two sentences within Common Standard 1 and Common Standard 4 and direct staff to also replace the term “stakeholder” anywhere it appears in program standards, glossaries, or other official Commission publications.

## Next Steps

If the Commission adopts the revisions for the two sentences in the Common Standards as well as staff’s request to make any similar changes as described in this item, all previous postings of the document on the Commission website and in Commission publications will be replaced with

the updated language. Additionally, staff will replace the word “stakeholder” in all other Commission standards and glossaries and replace previous versions with the updated copies.
