Thursday, December 8, 2022

General Session

Chair Tine Sloan convened the General Session of the Commission at 9:13 a.m. Roll call was taken, and the Pledge of Allegiance was recited.

Chair Sloan welcomed Student Liaison Mers Tran to the Commission. She also announced that this would be Commissioner Terri Jackson's last meeting.

1A: Approval of the October and November 2022 Minutes

Commissioner Hartwig moved approval of the October 2022 Ad Hoc Committee meeting minutes. Commissioner de la Torre seconded the motion. The motion carried without dissent.

Commissioner Martinez moved approval of the October 2022 Commission meeting minutes. Commissioner Jackson seconded the motion. The motion carried without dissent.

Commissioner Hartwig moved approval of the November 2022 Closed Session meeting minutes. Commissioner Grenot-Scheyer seconded the motion. The motion carried without dissent.

1B: Approval of the December 2022 Agenda

Commissioner Davis moved approval of the December 2022 Agenda with an agenda insert for item 1C. Commissioner Heredia seconded the motion. The motion carried without dissent.

1C: Approval of the December 2022 Consent Calendar

Commissioner Jackson moved approval of the December 2022 Consent Calendar with an amendment to withdraw item 26. Daniel Lee to be reviewed during Closed Session. Commissioner Davis seconded the motion. The motion carried without dissent. Commissioner Cruz recused himself from item 7. Sarah Brady; Commissioner de la Torre recused himself from item 33. Michael Rauseo; and Commissioner Cardenas recused himself from items 15. Rodney Flucas and 38. Duane Simpenderfer Jr.

1D: Chair's Report

Chair Sloan shared a personal story about her childhood and how she became an educator. She expressed her gratitude and respect for those who teach children every day and stated that she was grateful for the opportunity to help children through her work on the Commission and collaboration with other partners in the education community. She also expressed her appreciation to her students and colleagues at UC Santa Barbara and thanked Commissioners for the important work that they do for children.

1E: Executive Director's Report

Executive Director Sandy thanked Chair Sloan for her years of service on the Commission and introduced new consultants Sarah Barwani and Stephanie Morgado from the Professional Services Division. She also informed the public that staff is developing a process for programs to submit a proposal to offer the new PK-3 early childhood credential program which includes three new standards areas in literacy, diversity, equity and inclusion, and early mathematics.

1F: Commission Member Reports

Commissioner Davis provided an update on the CTA (California Teachers Association) and the National Board Resource Center at Stanford University cohort program for Black, Indigenous, and People of Color (BIPOC) candidates who are pursuing National Board Certification.

Commissioner Francois thanked Commissioner Jackson for her commitment and service to the students of California. She expressed her appreciation to Chair Sloan for her leadership and guidance at the University of California (UC) and for being an exemplary model of the work and dedication needed to develop and lead transformative, research-based and innovative high quality teacher education. She reported that the UC Board of Regents appointed Katherine Newman as UC Provost and Executive Vice President for Academic Affairs, effective January

2023. She provided updates regarding the 21st Century California School Leadership Academy, the Environmental and Climate Change Literacy Project, and the initiative of the California Community School Statewide Transformative Assistance Center (S-TAC). Lastly, she reported that Alison Towery was selected as Executive Director to lead the UC-CSU California Collaborative for Neurodiversity and Learning.

Commissioner Pavri congratulated Commissioner Jackson on her upcoming retirement and thanked Chair Sloan for her impactful leadership over the years. She also shared information about the Equity and Excellence Certificate Program available through the Center for Transformational Educator Preparation Programs (CTEPP).

Commissioner Browne thanked Commissioner Jackson and Chair Sloan for their work and expertise on the Commission. She acknowledged the collaboration between the Commission, the CSU, and the Community Colleges to transform preparation of PK-3 teachers. She also shared her excitement for the return of student teachers to in-person classroom settings.

Commissioner White-Smith acknowledged the citizens of the Kumeyaay nation and thanked them for their stewardship and contributions to the region. She also recognized the Commission's efforts to make it possible for all teachers to engage in work that is authentic and accurate historically. She introduced Robin Duncan, Dean Chair of the AICCU from California Baptist University, and Allison Smith, who represents the AICCU Ed faculty. She reported on the collaboration between the University of San Diego and San Diego State University to support San Diego Unified School District in developing a pathway for more minoritized teachers into the field through the residency program. She shared that the University of San Diego received a grant from the San Diego Foundation to support the development of the Black Ingenious Initiative. Finally, she thanked Commissioner Jackson and Chair Sloan for their thoughtfulness and advocacy for the work of the Commission.

Commissioner Jackson thanked everyone for their kind words. She also thanked Superintendent Tony Thurmond, and her colleagues and manager, Kristin Cruz Allen, at the Teacher and Leader Policy Office of the California Department of Education for their encouragement and support. She acknowledged Chair Sloan for her strength, passion and leadership and also recognized the California Teachers Association.

Commissioner Heredia reported on her attendance at the California School Boards Association 2022 Annual Education Conference in San Diego.

Commissioner Cardenas reported on his attendance at a Career Technical Education fair held by his district for 8th grade students.

1G: Liaison Reports

Haydee Rodriguez, State Board of Education Liaison, thanked Chair Sloan for her leadership and contributions to the work of the Commission and expressed her appreciation to Commissioner Jackson for her contributions to public education. Liaison Rodriguez reported that Linda Darling-Hammond, President of the California State Board of Education, was awarded the 2022

Yidan Prize for Education Research. Lastly, she reported on her attendance at the State Board's November 2022 meeting.

Commissioner Davis reported on his attendance at the October 2022 Committee on Accreditation meeting.

Mers Tran, Commission Student Liaison, thanked Commission staff, the interview panel, and Commissioner Davis and expressed excitement for being on the Commission. Student Liaison Tran spoke about their personal background and perspective on education and shared their interest in adding their voice and input at the table.

Educator Preparation Committee

Committee Chair Monica Martinez convened the Educator Preparation Committee.

2A: Annual Report of the Committee on Accreditation 2021-22

Martin Martinez and Robert Frelly, COA Co-Chairs, Cheryl Hickey and Erin Sullivan, Administrators, Professional Services Division, presented this item which provided the 2021-22 Annual Report of the Committee on Accreditation (COA).

2C: Proposed Adoption of the Passing Score Standard for the Revised California Subject Examinations for Teachers in Art and Music (CSET: Art and CSET: Music)

Mike Taylor, Consultant, Professional Services Division, presented this item which described the standard setting study for the revised California Subject Examinations for Teachers (CSET) in Art and Music (CSET: Art and CSET: Music) and provided recommended initial passing standards for each examination based on the recommendations from the CSET Standard Setting Panels.

Commission Action

Chair Sloan moved to adopt the proposed preliminary passing scores for each of the revised examinations with an adjustment of a negative 1.5 Standard Error of Measurement and to revisit the passing score standard within a year. Commissioner Klatt seconded the motion. The motion carried without dissent.

2B: Annual Report Card on California Teacher Preparation Programs for the Academic Year 2020-21

Cara Mendoza, Administrator, and Phi Phi Lau, Research Data Specialist, Professional Services Division, presented this item which provided the Annual Report Card on California Teacher Preparation Programs for the Academic Year 2020-21, as required by Title II of the 2008 Reauthorization of the federal Higher Education Act, including a description of credentialing requirements to teach in California public schools and qualitative and quantitative information on teacher preparation programs.

Melissa Figueira, Education Trust-West, raised concerns regarding the decrease in the percentage of Black candidates across all three segments at CSU, UC, and private institutions while the percentage of Latino candidates has plateaued over the last several years. She

suggested the Commission, state leaders, and higher education institutions actively work to use the data to inform the development of comprehensive solutions that can increase diversity in the educator workforce.

Friday, December 9, 2022

General Session

Chair Sloan reconvened the General Session of the Commission at 8:39 a.m. and roll call was taken.

Chair Sloan opened the public hearing.

1H: Proposed Regulations Regarding Options for Meeting the Subject Matter Competence Requirement

David DeGuire, Director, Professional Services Division, presented this item which framed the public hearing requested by a member of the public on the proposed regulations approved by the Commission at its June 2022 Commission meeting to clarify and standardize implementation of options for meeting the subject matter competence requirement in Education Code sections 44259 and 44310 that were created by Assembly Bill 130 (Chap. 44, Stats. 2021).

Commission Action

Commissioner Simmons moved to amend the proposed regulations adopted in June 2022 to remove section 80096(b)(9) and directed staff to move the amended regulatory package forward for submission to the Office of Administrative Law. The Commission directed staff to study and review all the domains within the subject matter requirements of single subject areas and to bring back an item with a plan at the February Commission meeting. Commissioner Heredia seconded the motion. The motion carried without dissent.

Professional Practices Committee

Committee Chair Johanna Hartwig convened the Professional Practices Committee.

3A: Division of Professional Practices Workload Report

Rachel Grizzaffi, Director, Division of Professional Practices, presented this item which provided a report on the Division of Professional Practices' current workload.

Educator Preparation Committee

Commissioner Martinez reconvened the Educator Preparation Committee.

2E: Initial Institutional Approval – Stage III: Consideration of Provisional Approval for Relay Graduate School of Education

Poonam Bedi and Hart Boyd, Consultants, Professional Services Division, presented this item which provided, as part of the Initial Institutional Approval process, Relay Graduate School of Education's responses to the Common Standards, Initial Program Preconditions, and General Precondition #9 for consideration and possible Provisional Approval by the Commission.

Alice Waldron, Maya Weatherton, and Davida Gatlin, Relay Graduate School of Education, assisted staff in presenting this item.

Commission Action

Commissioner Klatt moved to grant Provisional Approval to Relay Graduate School of Education and set the Provisional Approval period to be three years. Commissioner Martinez seconded the motion. The motion carried with Commissioners Cardenas, de la Torre, Grenot-Scheyer, Heredia, and Sloan in opposition, and Commissioner Jackson abstaining.

2F: Initial Institutional Approval – Stage V: Consideration of Full Institutional Approval for Alder Graduate School of Education

Jake Shuler and Tim Weekes, Consultants, Professional Services Division, presented this item which provided, as part of the Initial Institutional Approval process, the report from the Provisional Site Visit and the Committee on Accreditation's recommendation for an accreditation decision for Alder Graduate School of Education (Alder GSE).

Heather Kirkpatrick and Shayna Sullivan, Alder Graduate School of Education, assisted staff in presenting this item.

Nancy Magee, San Mateo County Office of Education, submitted a written comment which urged the Commission to move forward with full institutional approval for Alder Graduate School of Education.

Vitalis Obidi, Aspire Public Schools, submitted a written comment which voiced support for Alder Graduate School of Education.

Commission Action

Commissioner Heredia moved to grant Alder GSE full institutional approval. Commissioner Davis seconded the motion. The motion carried without dissent.

2D: National Board for Professional Teaching Standards Certification Incentive Program

David DeGuire, Director, Professional Services Division, presented this item which provided an update on the California Department of Education's Incentive Program for teachers to earn National Board for Professional Teaching Standards Certification.

Susan Olsen and Kristin Cruz Allen, California Department of Education, Sarah Pinsky and Stacey Hicks, National Board for Professional Teaching Standards, assisted staff in presenting this item.

Shilpa Ram, Public Advocates, asked staff a clarifying question regarding the incentive program.

Adam Ebrahim, California Teachers Association, expressed his appreciation for the National Board Incentive program.

2G: Update on the California Classified School Employee Teacher Credentialing Program

Iyore Osamwonyi, Consultant, Professional Services Division, presented this item which provided an update on the California Classified School Employee Teacher Credentialing Program and presented the 2022 Annual Report to the Legislature on the California Classified School Employee Teacher Credentialing Program.

Shilpa Ram, Public Advocates, asked the Commission whether the model of providing test prep and materials could be replicated and suggested the Commission consult with the grantees and Fresno State to gather more information about how and why the approach and collaboration have worked well to help improve the passage rates for students. She suggested that the Commission provide support and resources so more grantees are able to provide this service.

Commission Action

Commissioner Davis moved to approve the 2022 Annual Report to the Legislature on the California Classified School Employee Teacher Credentialing Program for transmittal to the Legislature. Commissioner Grenot-Scheyer seconded the motion. The motion carried without dissent.

2H: Update on the Development of Education Specialist Teaching Performance Assessments for Lower Incidence Credential Areas

James Webb, Consultant, Professional Services Division, presented this item which provided an update on the development of the Teaching Performance Assessment (TPA) for Education Specialist lower incidence credential areas of Deaf and Hard Hearing (DHH), Early Childhood Special Education (ECSE), and Visual Impairments (VI), and requested Commission approval for additional time for a comprehensive field test with the lower incidence credential areas of emphasis (DHH, ECSE, and VI).

Commission Action

Commissioner Simmons moved to approve the proposed timeline for the development of performance assessment guides for DHH, ECSE, and VI credential areas with a field test conducted in 2024-25 and operational administration beginning in fall 2025. Commissioner Grenot-Scheyer seconded the motion. The motion carried without dissent. Commissioners Brown and de la Torre were not present during the roll call vote.

Reconvene General Session

Chair Sloan reconvened the General Session.

1I: Strategic Planning Update

Amy Reising, Chief Deputy Director, Caitlin Vaccarezza, Vice President, and Aaron Price, President, the Glen Price Group, presented this item which provided a summary of strategic planning efforts conducted between 2020 and 2021, outlined the proposed process for completion of an updated strategic plan for the Commission, and requested the Commission's guidance to inform further development of the strategic plan.

1J: New Business

The Bimonthly Agenda was presented.

1K: Executive Director 2022 Annual Evaluation

Tine Sloan, Chair, Commission on Teacher Credentialing, presented this item which highlighted portions of the Executive Director's annual evaluation for disclosure to the public and discussed a merit salary adjustment be submitted to the California Department of Human Resources and the Governor's Office for approval.

Commissioner Grenot-Scheyer moved to approve a merit salary increase for Executive Director Sandy. Commissioner Martinez seconded the motion. The motion carried without dissent. Commissioners Brown and de la Torre were not present during this item.

1M: Report of Closed Session Items

The Commission reviewed the transcript in the matter of Kurt Wilkins. A Decision and Order will be prepared for the Commission's adoption. The Commission ordered a thirty-day delay for preparation of the Decision and Order.

The Commission rejected the Proposed Decisions in the matters of Manuel Madrid-Olguin, Stacy Mc Cay, Morgan Walton, and La Shawn Witt and called for the transcript.

Commissioner Davis moved to elect Marysol De La Torre-Escobedo as Vice Chair. Commissioner Cardenas seconded the motion. The motion carried without dissent. Commissioners Brown and de la Torre were not present during this item.
