#### **Report to the Legislature on the Implementation of Senate Bill 488 Teacher Credentialing – Reading Instruction**

Senate Bill 488 (Chap. 678, Stats. 2021) requires the Commission to (a) update its standards for the preparation of teacher candidates with respect to reading and literacy instruction, (b) review teacher preparation programs' progress in meeting the updated literacy standards, and (c) develop a new literacy performance assessment to replace the current Reading Instruction Competence Assessment (RICA) by 2025. The Commission is required to report to the Legislature annually regarding implementation of the provisions of SB 488. This agenda item presents the second annual report to the Legislature, including information on how constituencies were engaged in the process as called for in statute.
