# Program Approval

## **Introduction**

This agenda item presents one Single Subject Matter program submitted by an institution of higher education for approval.

## **Background**

The Commission regularly receives recommendations for program approval from subject matter review panels. The content specific subject matter standards are closely aligned to the TK-12 academic content standards. These subject matter programs are usually undergraduate courses of study completed before candidates begin teacher preparation programs. However, the two programs may be completed concurrently.

## **Subject Matter Program Review Procedures**

Subject matter educators review the submitting institution's response to the preconditions. The preconditions are based on both state laws and Commission policies and address the minimum unit and content area requirements. The institution's responses to the Commission's subject matter program standards are reviewed by a team of two or more subject matter educators to determine if the program meets the program standards, including the Subject Matter Requirements (SMRs). The SMRs are the content knowledge required to be covered in the program and are aligned to the K-12 content standards that the candidate will be expected to know. If the program does not meet the standards, the institution is given an explanation of the findings. The institution may then submit the additional information requested. Once reviewers determine that the program proposal provides a convincing and adequate body of evidence to meet the Commission's adopted subject matter program standards, the program is recommended to the Commission for approval. After subject matter program approval is granted by the Commission, the institution may admit candidates to the approved subject matter program. Graduates of a Commission-approved subject matter preparation program meet the Commission's SMRs and are not required to take the subject matter examination (California Subject Examinations for Teachers).

## **Summary of Information on the Proposed Single Subject Matter Program**

### **California State University, San Bernardino**

The Bachelor of Music in Pre-Certification at California State University, San Bernardino (CSUSB) program will provide students with the opportunity to demonstrate mastery of music subject matter requirements and work towards being qualified to earn a teaching credential at the K-12 level. The program allows students to complete courses comprehensively aligned with the content, concepts, and skills detailed in the California Music Framework. In particular, students complete a robust core of theory, history, and piano, as well as courses in music education pedagogy, artistic leadership, and program administration. The unique design of the program allows students to take courses in either (or both) instrumental and choral tracks, thus

combining choice and flexibility with rigor, breadth, and depth of learning. This option supports teachers to enter the profession with subject matter and pedagogical knowledge bases that are wide ranging, critical, and relevant.

The Department of Music, to support this endeavor, has created committees dealing with Curriculum and Assessment. The Bachelor of Music in Pre-Certification will be housed in the Department of Music and the College of Arts and Letters with a faculty advisor assigned as Coordinator for Music Education. Additionally, both the chairs of the department curriculum committee and assessment committee will work with the music education coordinator.

**Staff Recommendation**

Staff recommends that the Commission approve the subject matter program shown below:

## **Proposed Revisions to Program Standard 7: Effective Literacy Instruction for Education Specialist: Visual Impairments and Education Specialist Deaf and Hard-of-Hearing Credential Programs**

---

### **Introduction**

This agenda item presents changes to Program Standard 7: Effective Literacy Instruction for Students with Visual Impairments and Program Standard 7: Deaf and Hard-of-Hearing for the Education Specialist: Visual Impairments credential programs and Education Specialist: Deaf and Hard-of-Hearing credential programs respectively.

### **Background**

To address one of the issues raised by the field at the February 2023 Commission meeting, revisions are proposed to Program Standard 7 for both the Preliminary Education Specialist: Visual Impairments credential program and Preliminary Education Specialist: Deaf and Hard of Hearing credential program. The use of vision and hearing technologies was intended to be included in proposed standards at the February 2023 meeting but was not in the version that was presented. These changes would address that omission.

### **Proposed Revisions to Program Standard 7 for Education Specialist: Visual Impairments and Program Standard 7: Effective Literacy Instruction for Deaf and Hard-of-Hearing Students**

Staff proposes the following changes to Program Standard 7: Effective Literacy Instruction for Students with Visual Impairments for Education Specialist: Visual Impairment credential programs and Program Standard 7: Effective Literacy Instruction for Deaf and Hard-of-Hearing Students for Education Specialist: Deaf and Hard-of-Hearing credential programs. The paragraphs are identical in both sets of standards and the proposed changes are also identical. The underlined language is proposed to be added, while the strikethrough is proposed to be deleted. The text of the full standard adopted by the Commission at its February 2023 meeting can be found at: [Agenda Item 4C](#) pages 10 (Visual Impairments) and page 26 (Deaf and Hard of Hearing). These changes would address the issue of ensuring that programs prepare candidates to include the use of vision and hearing technologies, as appropriate, in their repertoire of approaches to literacy instruction.

In addition, the program teaches candidates about the impact of deafblindness on literacy learning and receptive and expressive communication. Candidates learn tactile and other instructional approaches, including the use of vision and hearing technologies as appropriate, to teach literacy to students who are deafblind. They also learn about communicating with students who are deafblind via tactile American Sign Language, pro-tactile American Sign Language, and haptics, as well as through the use of vision and hearing technologies as appropriate. Candidates learn ~~and~~ to collaborate with specialists and interveners for hearing assessments and to directly support students' literacy learning.

**Staff Recommendation**

Staff recommends that the Commission approve the proposed changes as described above to Program Standard 7 for both Education Specialist: Visual Impairments credential programs and Education Specialist: Deaf and Hard of Hearing credential programs.
