#### **Report to the Legislature on the Implementation of Senate Bill 488 Teacher Credentialing – Reading Instruction**

Senate Bill 488 (Chap. 678, Stats. 2021) requires the Commission to (a) update its standards for the preparation of teacher candidates with respect to reading and literacy instruction, (b) review teacher preparation programs' progress in meeting the updated literacy standards, and (c) develop a new literacy performance assessment to replace the current Reading Instruction Competence Assessment (RICA) by 2025. The Commission is required to report to the Legislature annually regarding implementation of the provisions of SB 488. This agenda item presents the second annual report to the Legislature, including information on how constituencies were engaged in the process as called for in statute.

#### **Proposed Plan for the Replacement of the Reading Instruction Competence Assessment (RICA)**

This agenda item presents for review and potential adoption a plan to retire the RICA and replace it with a literacy instruction performance assessment by July 1, 2025, as required by Senate Bill 488 (Chap. 678, Stats. 2021). The item will also identify the SB 488 requirements for demonstrating competence in reading instruction for multiple subject general education, education specialist, and PK-3 teacher candidates. Finally, it will identify situations in which a reading instruction exam may still be needed for various types of educators who are not in a

clinical practice setting beyond July 1, 2025, to assess competence in reading instruction and possible options for those situations.
