3A: Approval of the February 2023 Minutes

3B: Approval of the April 2023 Agenda

3C: Approval of the April 2023 Consent Calendar

3D: Chair's Report

There was no report.

3E: Executive Director's Report

Executive Director Sandy introduced Bronwyn Kennedy, a new Consultant with the Professional Services Division, and Anita Fitzhugh, the new Public Information Officer with the Office of Governmental Relations. Executive Director Sandy also provided a brief overview of the April Commission meeting agenda.

3F: Commission Member Reports

Commissioner Browne provided an update regarding the work on the PK-3 Early Childhood Education Specialist Instruction credential and the development of teacher apprenticeship programs at community colleges. She also spoke about the restructuring of the California Early Childhood Mentor Program and expressed her appreciation for being a participant in the UPK Mixed Delivery Quality and Access Workgroup.

Commissioner Cardenas reminded everyone that May is Mental Health Awareness Month and reported on his attendance at the SkillsUSA Leadership and Skill Conference in Ontario, CA.

GS 1A-3 June 2023

Commissioner Davis reported on his attendance at the 2023 California Teachers Association Good Teaching Conference (South) and spoke about his first National Board Certification Pinning Ceremony. He talked about his experience of having Dr. Melba Beals of the Little Rock Nine speak to the students in his class. He also voiced the importance of mental health awareness and expressed his appreciation for the services provided by counselors, social workers, and mental health professionals.

Vice Chair De La Torre-Escobedo expressed her sympathies on the loss of her colleague, Steven Tadeo and shared a poem "Prayer for the Morning" by Audette Fulbright.

Commissioner White-Smith conveyed her condolences to Vice Chair De La Torre-Escobedo on the loss of her colleague. She shared information about the celebration of Autism Awareness Day and Neurodiversity Week at the University of San Diego. She also reported on the work by the AICCU on diversifying the teacher pipeline as well as expanding the number of counselors, principals, and other leaders in their education community.

Superintendent Thurmond acknowledged and offered his condolences to the community on the loss of Steven Tadeo and thanked Commissioners for speaking about the various needs around mental health awareness. He shared highlights regarding the efforts by the California Department of Education (CDE) on residency programs and literacy.

3G: Liaison Reports

Mers Tran, Commission Student Liaison, thanked Commissioners who spoke in support of mental health awareness month. Student Liaison Tran also provided an update on the UC Berkeley education program and the current landscape of education.

Haydee Rodriguez, State Board of Education Liaison, reported on her attendance at the State Board's March 2023 meeting. She also provided an update regarding the work of the National Association of State Boards of Education (NASBE) on transforming and redesigning schools.

Professional Practices Committee

Committee Chair Johanna Hartwig convened the Professional Practices Committee.

4A: Division of Professional Practices Workload Report

Rachel Grizzaffi, Director, Division of Professional Practices, presented this item which provided a report on the Division of Professional Practices' current workload.

Educator Preparation Committee

Committee Chair Monica Martinez convened the Educator Preparation Committee.

5A: Review of the Passing Score Standards for the California Subject Examinations for Teachers in Dance and Theatre (CSET: Dance and CSET: Theatre)

Mike Taylor, Consultant, Professional Services Division, presented this item which described the process used to review the existing minimum passing standards for CSET: Dance and for CSET:

Theatre and provided updated minimum passing score standards for potential adoption by the Commission.

Commission Action

Commissioner de la Torre moved to accept staff recommendation to set the passing score for each subtest at the panel-recommended passing score standard with a -2 SEM adjustment. Commissioner Davis seconded the motion. The motion carried without dissent. Chair Grenot-Scheyer was not present during this item.

5B: Review and Proposed Adoption of the Revised California Teaching Performance Assessment Design Standards

Heather Kennedy and James Webb, Consultants, Professional Services Division, presented this item which provided proposed revisions to the adopted California Teaching Performance Assessment Design Standards and requested that the Commission authorize the use of these updated standards to develop Literacy Teaching Performance Assessments as required by SB 488 (Chap. 678, Stats. 2021).

Harold Acord, California Teachers Association, expressed his appreciation for the thoughtful integration of the new Literacy Teaching Performance Expectations into the performance assessment design standards and the explicit requirement for assessor programs to ensure assessors are equipped with a deep knowledge of implicit bias as it relates to their duties. He urged the Commission to be mindful of the scope of the new assessment to ensure it complements the clinical practice in teacher preparation programs and encouraged the Commission to engage teacher candidates, new teachers, mentors, and professors to provide feedback throughout the development of the successor to the RICA as required by SB 488.

Allison Smith, Association of Independent California Colleges and Universities-Education, submitted a written comment in support of switching to a performance assessment and embedding it within the Teaching Performance Assessment.

Commission Action

Commissioner Davis moved to adopt the recommended changes in Appendix A of this item with the following additional suggestions 1: address issues on race and hair, and gender and gender expression; 2: be inclusive of any form of potential bias as outlined in Penal Code 422.55 and AB 537; and 3: include live links as a reference for further clarification on these areas of potential bias and authorize the use of the California Teaching Performance Assessment Design Standards to direct the development of literacy performance assessments that reflect the full continuum of placements for multiple subject general education, PK-3, and education specialists. Commissioner de la Torre second the motion. The motion carried without dissent.

5C: Teacher Supply in California, 2021-22 A Report to the Legislature

David DeGuire, Director, Cara Mendoza, Administrator, and Phi Phi Lau, Research Data Specialist, Professional Services Division, presented this item which provided a report to the Governor and the Legislature on the number of teachers who received credentials, certificates,

permits and waivers to teach in California public schools. In addition to the written Teacher Supply report, information on the educator supply dashboards was updated with the most recent data.

Erin Githens, California Teachers Association, voiced concerns regarding the data on new hires in relation to the projected increase for the 2022-23 school year. She expressed that while the data underscores the ongoing staffing crisis it does not suggest avenues for understanding the root causes within the Commission's purview and suggested a discussion about what data, including intentional listening and learning with new teachers and teacher candidates could lead to greater insights to this issue.

Liz Guillen, Public Advocates, suggested that the agency's top-line findings be front and center in the executive summary on the front page of the report. She raised concerns about the reversal of the trend in the number of newly credentialed teachers and the lack of complete data on the number of fully prepared teachers that are currently serving. She also shared recommendations from the executive summary of the California Educator Diversity Road Map developed by Public Advocates, Californians for Justice, and Education Trust-West.

Jana Luft, Education Trust-West, spoke about the importance of the public having access to data about the educator workforce to guide efforts that ensure all students, especially students of color and those from low-income households, have diverse and effective educators. She raised concerns regarding missing data which makes it impossible to gauge the discrepancy between teacher and student diversity for the last three years at the school district or the county levels and requested these data be made available as soon as possible.

Manuel Buenrostro, Californians Together, elevated the concerns that were raised by Public Advocates and Education Trust-West about the gaps in the data in the current report and voiced the support of more data transparency. He echoed the support for the recommendations of the CDE Educator Diversity Advisory Group and the need to continue to focus on recruitment, retention, and the support for teachers in high need areas. He suggested a more complete picture of the different bilingual authorizations that are provided to educators be included in table 9a of this item.

Kathy Thompson, Tulare County Office of Education, submitted a written comment which expressed an interest in collecting data on California teachers leaving the state.

5D: Revisit of the February 2023 Update on Residency Grant Programs

Cara Mendoza, Administrator, Kristina Najarro, Lynn Larsen, Sarah Barwani, Consultants, Professional Services Division; Andrew Brannegan and Kate Hirschboeck, Senior Research Associates, WestEd, presented this item which provided a follow-up to the February 2023 update on the Teacher Residency Grant Program funded by 2018, 2021, and 2022 legislation and on the Statewide Residency Technical Assistance Center and School Counselor Residency Programs authorized by 2022 legislation. Commission staff and the project team from WestEd also reviewed key findings and answered questions about the data presented in the February 2023 agenda item.

Allison Smith, Association of Independent California Colleges and Universities-Education, submitted a written comment which shared struggles that have been experienced at some of their institutions.

Commissioner de la Torre moved to approve the revised proposed regulations in Appendix B of this item with the deletion of the word "credential" in subdivision (b) paragraph (4) and to also add the following majors: child and family studies, early childhood studies, human development and family science, family science, and child adolescent and family studies for meeting the subject matter competence requirement for the PK-3 ECE Specialist Instruction credential. Commissioner Davis seconded the motion. The motion carried without dissent. Superintendent Thurmond was not present during this item.

3I: Proposed Amendments to Title 5 of the California Code of Regulations Pertaining to the PK-3 Early Childhood Education Specialist Instruction Credential

David DeGuire, Director, and Phyllis Jacobson and Renee Marshall, Administrators, Professional Services Division, presented this item which provided proposed regulations relating to California Code of Regulations (CCR), 80067, 80067.1, 80067.2, and 80067.3 approved by the Commission at its December 2022 Commission meeting to implement the PK-3 Early Childhood Education (ECE) Specialist Instruction Credential and the accompanying Program Preconditions, Program Standards, and Teaching Performance Expectations (TPEs), along with an analysis of and responses to public comments on the draft regulations received prior to the Commission meeting and proposed amendments to the draft regulations for the Commission's consideration.
