From Beslan, Sandy Hook and Parkland, to the dozens of schools under lockdown each day in America, the ubiquity of school-based violence causes profound harm to children, families and communities globally. 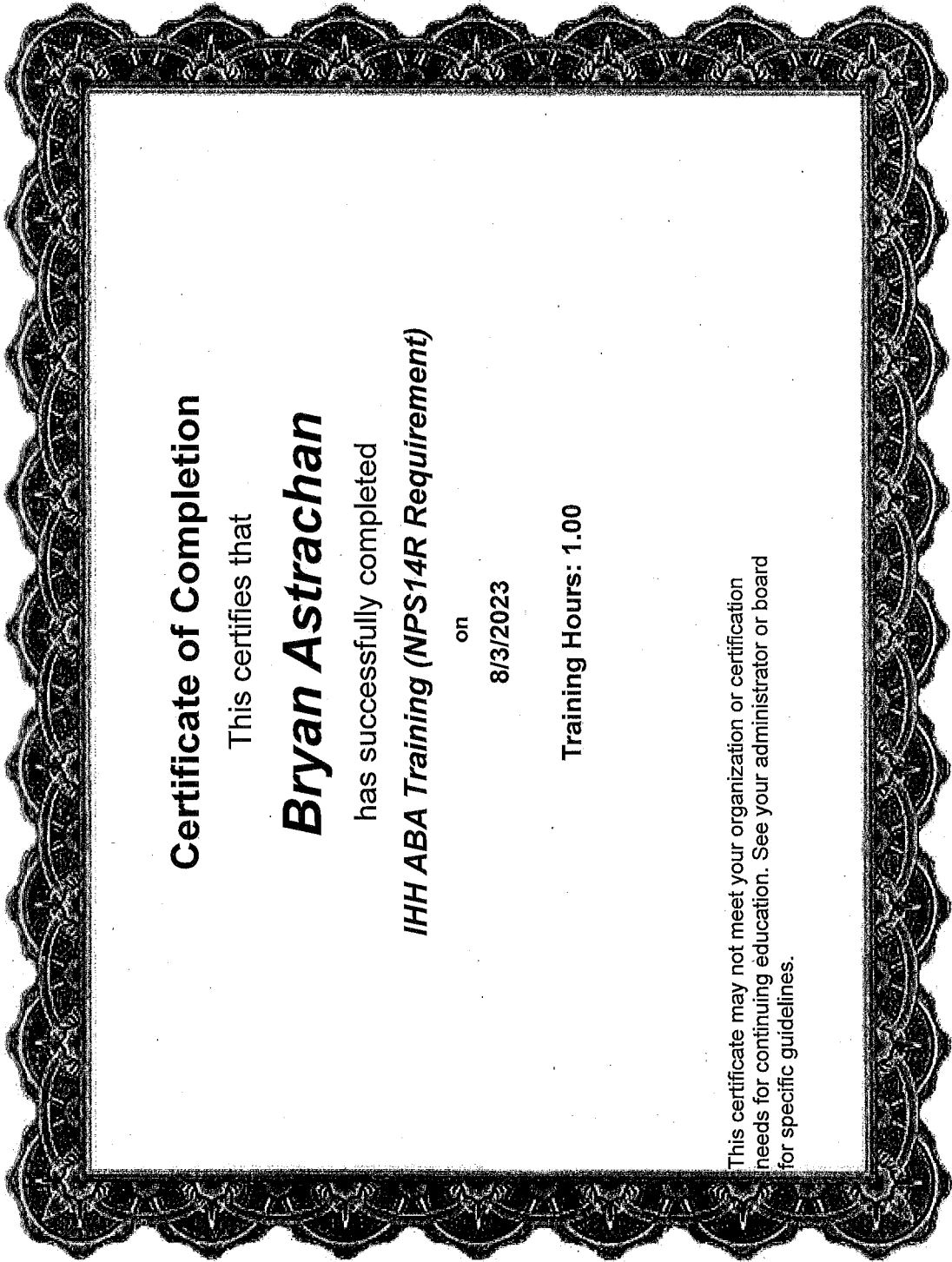
