SUBJECT: Proposed Changes in Title 5 Regulations for Single Subject
Waiver Programs and Supplementary Authorizations, Sections
80088 and 80089.

In accordance with Commission policy and administrative regulations in the California Government Code, the above cited Title 5 Regulations are distributed prior to public hearing. The public hearing to amend these regulations is scheduled as follows:

March 3, 1983
1:30 p.m.
Capitol Plaza Holiday Inn

Sacramento, California

Specifically, these regulations make the following changes:

- (1) Repeal (c) of Section 80088, because the Commission already has the authorization to exercise its discretion in utilizing panels in the review of single subject matter waiver programs by virtue of Education Code Section 44225(e).
- (2) Amend Sections 80088, 80089 to provide for a more realistic time-line, and to prevent any adverse effects on candidates presently enrolled in existing single subject waiver programs approved by the Commission.

Proposed Title 5 Regulations

80088. Approval of Programs of Academic Preparation.

- (a) The institution shall submit seven (7) copies of the program of academic preparation and the letter from the responsible head of the institution, as cited in Section 80087;
- (b) Commission staff will review the proposed program of academic preparation in terms of the general requirements, as stipulated in Section 80085.1;
- ~~(c) -- The Commission will appoint panels to review the program of academic preparation for each of the statutory single subjects, in terms of the specific requirements as stipulated in Section 80086, and breadth and perspective to supplement the essential core. -- Each panel will be comprised of secondary and college/university teachers of the subject and supplemented by one public school specialist in curriculum or school administration;~~
- (c)(d) Subject matter programs that meet the requirements in Title 5 Regulations, Section 80085.1 and 80086 may be submitted to the Commission for review and approval/denial deny as of July 1, 1982;
- (d)(e) Candidates initially enrolled in a subject matter program after January 1 June 30, 1984 shall be so enrolled in a Commission approved program that meets the requirements described in Title 5 Regulations Sections 80085.1 and 80086;
- (e)(f) Subject matter programs approved under regulations that existed on March 31, 1982 shall retain their approved status until January 1 June 30, 1984;
- (f)(g) Candidates who are progressing toward the completion of single subject matter programs, approved under regulations that existed on March 31, 1982, shall have until September 1, 1985 June 30, 1986 to complete requirements and apply for the appropriate single subject credential.

80089. Subjects Added as Supplementary Authorizations.

- (a) The holder of a valid single subject teaching credential may have one or more of the subjects, taught in the public schools of California, as listed in Section 80089.1 and 80089.2, added as a supplementary authorization. The candidate or an approved institution shall verify completion of 20 semester hours or 10 semester hours of upper division non-remedial collegiate coursework in a subject listed in Sections 80089.1 or 80089.2, with a scholarship record of grade C or better in any course used to meet requirements of this section. The course work shall be completed through regionally accredited institutions or institutions specially approved by the Commission.
- (b) Applicants for supplementary authorizations in subject matter categories other than industrial arts, physical education, music, art, or home economics shall meet the reading requirement described in Education Code Section 44259(e).

(c) Authorization.

(1) A supplementary authorization added under the provisions of Section 80089.1 authorizes the holder to teach that subject at any grade level; pre-school, kindergarten, grades 1-12, or in classes organized primarily for adults;

(2) A Supplementary Authorization added under the provisions of Section 80089.2 authorize the holder to teach the subject matter content that is typically included within curriculum guidelines and textbooks for study in grades 9 and below.

(d) Applicants who are progressing toward completion of supplementary authorization requirements as they existed on March 31, 1982 shall have until January-7 June 30, 1983 to apply for said authorizations.
