<b>SUBJECT: Proposed Amendments to Title 5 of the California Code of Regulations Pertaining to Multiple and Single Subject Teaching Credentials for Out-of-State Credentialed Teachers</b>

### **Authority and Reference**

Pursuant to the authority vested by Section 44225 of the Education Code, and to implement, interpret or make specific Section 44274.2 of the Education Code, the Commission on Teacher Credentialing is proposing amendments to 5 California Code of Regulations §§ 80413.3 and 80430.2.

### **Informative Digest/Policy Statement Overview**

#### Summary of Existing Laws and Regulations

The proposed amendments to Title 5 of the California Code of Regulations will clarify and interpret the Education Code (EC) sections pertaining to the requirements for out-of-state credentialed teachers seeking Multiple Subject and Single Subject Teaching Credentials in California.

The Title 5 sections referenced in this item (§§80413.3 and 80430.2) were last amended in January 2000. Since that time, the Legislature has passed and the Governors have signed several major pieces of legislation affecting the issuance of California teaching credentials to out-of-state credentialed teachers and Commission staff has been relying on the language provided in statute when determining academic eligibility. However, it has become apparent that Title 5 regulations are required to clarify several requirements listed in EC §44274.2. Especially needed are the definitions for full-time teaching experience, performance evaluations, subject matter competence, and professional level teaching credential, as well as clarification of the induction program and basic skills requirements. The proposed regulations also include the requirement that individuals earn a California English learner authorization to qualify for the clear teaching credential as specified in EC §44274.2.

### **Proposed Amendments to Regulations**

#### §80413.3

**Title:** Amendments to EC §44277 removed professional growth activities and successful service as renewal requirements for professional clear teaching credentials. As a result, the Commission has been issuing Clear Multiple and Single Subject Teaching Credentials since January 1, 2007. The title of §80413.3 has been amended to remove the word ‘professional’ from the credential title. The title of this section has also been amended to remove the word ‘experienced’, as there is an experience route and a non-experience route available to out-of-state credentialed teachers in EC §44274.2.

**(a):** Statutes in effect from September 1998 to October 2000 allowed for the issuance of a five-year preliminary teaching credential to individuals with five or more years of appropriate out-of-

state teaching experience. The experience route available to out-of-state credentialed teachers in EC §44274.2(b) requires two years of appropriate out-of-state teaching experience. This section has been amended to change ‘five’ to ‘two’ in relation to the years of required teaching experience. The word ‘earned’ has been added to clarify the teaching experience requirement. In addition, ‘U.S. territory’ has been added to allow individuals residing in U.S. territories who have acceptable teaching experience to apply via the experience route.

**(a)(1):** The reference to subsection ‘(G)’ has been amended to ‘(H)’ to accurately reflect the list of requirements necessary to qualify via the experience route due to the addition of the subject matter competence requirement.

**(a)(1)(A):** The experience route available to out-of-state credentialed teachers in EC §44274.2(b) requires two years of appropriate out-of-state teaching experience. This subsection has been amended to change ‘five’ to ‘two’ in relation to the years of required teaching experience. The word ‘earned’ has been added to clarify the teaching experience requirement and ‘U.S. territory’ has been added to allow individuals residing in U.S. territories who have acceptable teaching experience to apply via the experience route. The current statute no longer restricts the out-of-state teaching experience to the subject of the credential sought in California. Therefore, the reference to this previous requirement has been deleted.

**(a)(1)(B):** EC §44274.2(b) requires submission of two performance evaluations from separate years of the verified out-of-state teaching experience in a manner prescribed by the Commission. The word ‘rigorous’ has been deleted from this section to align with the language of EC §44274.2(b).

**(a)(1)(C):** An out-of-state prepared teacher must provide verification that he/she earned a professional level teaching credential in another state to qualify for a California teaching credential under current statute, but the credential does not need to be valid at the time of application. This subsection has been amended to remove the word ‘valid’ and to add ‘professional level’ to clarify the type of out-of-state certification necessary to qualify for the preliminary. ‘U.S. territory’ was also added to allow individuals residing in U.S. territories to apply via the experience route. Further, the reference to a comparable authorization has been deleted as this issue will be clarified in subsection (c)(1).

**(a)(1)(D):** Subject matter competence is one of the requirements listed in EC §44274.2(a)(3). This subsection has been added to list the subject matter requirement for out-of-state credentialed teachers. Definitions for the subject matter competence requirement will be provided in subsection (c)(1).

**(a)(1)(E):** This subsection has been re-lettered from (D) to (E) due to the addition of the subject matter competence requirement referenced above. With the prevalence of alternative teacher preparation programs, the reference to the student teaching requirement for the out-of-state

program has been deleted and the option for completion of a state-approved program offered by a local educational agency has been added to align with the language provided in EC §44274.2(a)(2). The language requiring that the program be in the area of the California credential sought and requiring approval by the state agency where the program was completed has been deleted. The current statute does not specify that the program must be in the area of the California credential sought or that the credential must be issued by the state in which the program was completed.

**(a)(1)(F):** This subsection has been re-lettered from (E) to (F) due to the addition of the subject matter competence requirement in subsection (D).

**(a)(1)(G):** This subsection has been re-lettered from (F) to (G) due to the addition of the subject matter competence requirement in subsection (D). The experience routes available under the previous statutes required an academic degree major to qualify for the Preliminary Single Subject Teaching Credential. The academic degree major is not required under current statute and the degree major of an applicant for a Preliminary Single Subject Teaching Credential will only be reviewed if the out-of-state credential does not list a comparable authorization. Therefore, the language requiring the academic degree major has been deleted and language requiring submission of an application form, processing fee, and fingerprint clearance has been added.

**(a)(1)(H):** This subsection has been re-lettered from (G) to (H) due to the addition of the subject matter competence requirement in subsection (D). EC §44252 allows for additional options to passage of the California Basic Educational Skills Test (CBEST) to satisfy the basic skills requirement. The proposed change is to update the basic skills requirement language in this subsection to match and align with statute. The subsection language has also been amended to delete reference to a one-year non-renewable credential and to explain that individuals who meet all requirements for the preliminary except the basic skills requirement may be issued the five-year credential. Individuals issued a preliminary prior to satisfying the basic skills requirement must satisfy the requirement within one year of the issue date for the five-year Preliminary Multiple or Single Subject Teaching Credential or the document will become invalid.

**(a)(2):** The language of this section has been reworded for clarity by stating at the beginning that it provides the requirements for the clear teaching credential, removing the word ‘professional’ from the credential title as the Commission has been issuing clear teaching credentials since January 1, 2007, and by indicating that the listed requirements pertain to preliminary teaching credentials issued via the experience route. The word ‘both’ was also deleted as there are more than two requirements for the clear teaching credential.

**(a)(2)(A):** The amendments to EC 44274.2 make it possible for an individual to qualify for a Clear Multiple or Single Subject Teaching Credential on initial application if all requirements are met. Therefore, the requirement that an individual first be issued a preliminary teaching

credential has been deleted from this subsection and the requirement that an individual earn a California English learner authorization to qualify for the clear teaching credential has been added. The word ‘and’ has been removed from the end of the subsection because there are more than two requirements for the clear teaching credential.

**(a)(2)(B):** Prior statute associated with the five-year experience route required only the completion of 150 clock hours of activities. EC §44274.2(b)(1) allows an additional option to the 150 clock hours. This subsection has been amended to allow for addition of the second option.

**(a)(2)(B)1:** Subsection has been added to explain that a master’s degree or higher in a field related to the credential, or the equivalent number of graduate-level semester units, is one of the options available as a renewal requirement for the experience route.

**(a)(2)(B)2:** Subsection renumbered to allow for addition of the master’s degree option described above. Deleted the word ‘following’ from the first sentence, as the definition of the 150 clock hours will be provided in section (c), and amended ‘standards’ to the full title of ‘California Standards for the Teaching Profession (CSTP)’. The remainder of this subsection has been deleted and will be added to the definitions provided in section (c).

**(a)(2)(C):** Subsection added to clarify that an individual may apply for a clear teaching credential with his/her initial application as long as all requirements listed in section (a) are met and the individual has not previously been issued a preliminary teaching credential. The subsection language further clarifies that an individual who meets all requirements for the clear credential except the basic skills requirement will be issued a five-year preliminary teaching credential.

**(a)(2)(D):** Subsection added to require submission of an application form and processing fee for issuance of the clear teaching credential.

**(b):** Statutes in effect from September 1998 to October 2000 allowed for the issuance of a three-year preliminary teaching credential to individuals with three or four years of appropriate out-of-state teaching experience. EC §44274.2 provides two routes to California certification for out-of-state credentialed teachers: an experience route for individuals with two or more years of appropriate out-of-state teaching experience and a non-experience route for individuals with less than two years of appropriate out-of-state teaching experience. This section has been amended to delete ‘three’ and to add ‘less than two’ to indicate that the language applies to the non-experience route. In addition, ‘U.S. territory’ has been added to allow individuals residing in U.S. territories to apply via the non-experience route.

**(b)(1):** The current statutes in effect allow for issuance of a five-year preliminary teaching credential, regardless of the number of years of out-of-state teaching experience verified by the applicant. The word ‘three’ has been amended to ‘five’ in relation to the term of the preliminary

teaching credential and the ‘H’ has been changed to an ‘F’ due to later amendments to this subsection.

**(b)(1)(A):** The language requiring verification of three years of full-time teaching experience has been deleted as such verification is not required via the non-experience route. Subsection (C) has been re-lettered to (A) and amended to align with current statute. An out-of-state prepared teacher must provide verification that he/she earned a professional level teaching credential in another state to qualify for a California teaching credential, but the credential does not need to be valid at the time of application. This subsection has been amended to remove the word ‘valid’ and to add ‘professional level’ to clarify the type of out-of-state certification necessary to qualify for the preliminary. ‘U.S. territory’ was also added to allow individuals residing in U.S. territories to apply via the experience route. Further, the reference to a comparable authorization has been deleted as this issue will be clarified in subsection (c)(1).

**(b)(1)(B):** The language requiring submission of rigorous performance evaluations has been deleted, as submission of such evaluations is not required via the non-experience route. This subsection will be used to list subject matter competence which is one of the requirements listed in EC §44274.2(a)(3).

**(b)(1)(C):** This subsection has been re-lettered from (D) to (C) due to the amendments explained above. With the prevalence of alternative teacher preparation programs, the reference to the student teaching requirement for the out-of-state program has been deleted and the option for completion of a state-approved program offered by a local educational agency has been added to align with the language provided in EC §44274.2(a)(2). The language requiring that the program be in the area of the California credential sought and requiring approval by the state agency where the program was completed has been deleted. The current statute does not specify that the program must be in the area of the California credential sought or that the credential must be issued by the state in which the program was completed.

**(b)(1)(D):** This subsection has been re-lettered from (E) to (D) due to the amendments explained above.

**(b)(1)(E):** This subsection has been re-lettered from (F) to (E) due to the amendments explained above. The experience routes available under the previous statutes required an academic degree major to qualify for the Preliminary Single Subject Teaching Credential. The academic degree major is not required under current statute and the degree major of an applicant for a Preliminary Single Subject Teaching Credential will only be reviewed if the out-of-state credential does not list a comparable authorization. Therefore, the language requiring the academic degree major has been deleted and language requiring submission of an application form, processing fee, and fingerprint clearance has been added

**(b)(1)(F):** This subsection has been re-lettered from (H) to (F) due to the amendments explained above. EC §44252 allows for additional options to passage of the California Basic Educational Skills Test (CBEST) to satisfy the basic skills requirement. The proposed change is to update the basic skills requirement language in this section to match and align with statute. The subsection language has also been amended to delete reference to a one-year non-renewable credential and to explain that individuals who meet all requirements for the preliminary except the basic skills requirement may be issued the five-year credential. Individuals issued a preliminary prior to satisfying the basic skills requirement must satisfy the requirement within one year of the issue date for the five-year Preliminary Multiple or Single Subject Teaching Credential or the document will become invalid.

**(b)(1)(G):** The language in this subsection has been deleted as employment in California is not a requirement for a five-year preliminary teaching credential issued via the non-experience route.

**(b)(1)(H):** Re-lettered to (F) as explained above.

**(b)(2):** The language of this section has been reworded for clarity by stating at the beginning that it provides the requirements for the clear teaching credential, removing the word ‘professional’ from the credential title as the Commission has been issuing clear teaching credentials since January 1, 2007, and by indicating that the listed requirements pertain to preliminary teaching credentials issued via the non-experience route. The word ‘both’ was also deleted as there are more than two requirements for the clear teaching credential.

**(b)(2)(A):** The statute in effect allows for issuance of a five-year preliminary teaching credential, regardless of the number of years of out-of-state teaching experience verified by the applicant. The word ‘three’ has been amended to ‘five’ in relation to the term of the preliminary teaching credential and the word ‘and’ has been deleted from the end because there are more than two requirements for the clear teaching credential.

**(b)(2)(B):** EC §44274.2(c)(2) requires completion of a beginning teacher induction program pursuant to EC §44259(c)(2) for individuals who qualify via the non-experience route. This subsection has been amended to reflect the one program option that was previously provided in (b)(2)(B)(1) and to cite the Title 5 section that interprets the beginning teacher induction program requirement listed in EC §44259(c)(2).

**(b)(2)(B)(1):** The language of this subsection will be included in (b)(2)(B).

**(b)(2)(B)(2):** This subsection has been deleted because there is only one type of beginning teacher support and assessment program referenced in EC §44274.2(c)(2) and language requiring completion of the program will be included in (b)(2)(B).

**(b)(2)(C):** This subsection has been added to explain that an individual must earn a California English learner authorization to qualify for the clear teaching credential.

**(b)(2)(D):** Subsection added to require submission of an application form and processing fee for issuance of the clear teaching credential.

**(c)(1):** Subject matter competence is one of the requirements listed in EC §44274.2(a)(3). This subsection has been amended to define the subject matter competence requirement listed in subsections (a)(1)(D) and (b)(1)(B) by describing the types of out-of-state teaching credentials that will satisfy the requirement for Multiple and Single Subject Teaching Credentials. The language referencing an academic degree major for the Single Subject Teaching Credential required under previous statute has been deleted.

**(c)(1)(A):** Under previous statute, the experience route for out-of-state credentialed applicants for the Single Subject Teaching Credential required an academic major in the subject area requested to qualify. An academic major is not a requirement under current statute, so the list of academic majors for the Agriculture authorization has been deleted. Language has been added to the subsection to allow an individual who holds an out-of-state middle school credential to qualify for a Preliminary Multiple Subject Teaching Credential and explains that subject matter competence must be verified for issuance of the clear credential. Several states issue stand-alone teaching credentials for middle school instruction that are not comparable to any authorization available in California.

**(c)(1)(B):** Under previous statute, the experience route for out-of-state credentialed applicants for the Single Subject Teaching Credential required an academic major in the subject area requested to qualify. An academic major is not a requirement under current statute, so the list of academic majors for the Art authorization has been deleted. The statutory authorizations available for the Single Subject credential in California are listed in EC §44257. This subsection has been amended to explain how an individual with an out-of-state middle school or departmentalized classroom teaching credential in an area that is not comparable to an authorization listed in EC §44257 may verify his/her subject matter competence with a degree major or 32 semester units in the subject area sought. A degree major or 32 semester units in a subject area aligns with the No Child Left Behind state plan for highly-qualified teachers. .

**(c)(1)(C):** Under previous statute, the experience route for out-of-state credentialed applicants for the Single Subject Teaching Credential required an academic major in the subject area requested to qualify. An academic major is not a requirement under current statute, so the list of academic majors for the Business authorization has been deleted. This subsection has been further amended to allow an individual who holds an out-of-state middle school or departmentalized classroom teaching credential that is not comparable to an authorization listed in EC §44257 and who does not have a degree major or 32 semester units in the subject area sought to qualify for a Preliminary Single Subject Teaching Credential. The subsection also explains that subject matter competence must be verified for issuance of the clear credential.



**(c)(1)(D) through (c)(1)(P):** Under previous statute, the experience route for out-of-state credentialed applicants for the Single Subject Teaching Credential required an academic major in the subject area requested to qualify. An academic major is not a requirement for the Single Subject Teaching Credential under current statute, so the list of academic majors for the English, Foreign Language, Health Science, Home Economics, Industrial and Technology Education, Mathematics, Music, Physical Education, Science: Biological Sciences, Science: Chemistry, Science: Geoscience, Science: Physics and Social Science authorizations have been deleted.

**(c)(2):** This subsection has been amended to include out-of-state regionally-accredited private schools as appropriate employers for the experience route, add ‘U.S. territories’ to clarify that individuals residing in U.S. territories may apply via the experience route, and delete the reference to ‘state’ as related to the teaching experience since U.S. territories are not considered states. Also, the requirement that the out-of-state credential be comparable to a California authorization has been deleted since the current statute no longer requires that the out-of-state teaching experience be in the area of certification sought in California. The references to ‘districts’ as related to the required experience letter have been replaced with ‘out-of-state employer’, because private schools are not considered districts.

**(c)(3):** EC §44274.2(b) requires submission of two performance evaluations from separate years of the verified out-of-state teaching experience in a manner prescribed by the Commission. The word ‘rigorous’ has been deleted from this section to align with the language of EC §44274.2(b).

**(c)(3)(A):** The word ‘must’ has been replaced with ‘may’ to indicate that the definition provided for the performance evaluations should be used as a guide. Also, the language stating that an individual would not qualify under the section if all performance areas were not covered in the evaluations and requiring submission of an evaluation authenticity letter have been deleted. Specific areas and an evaluation authenticity letter are not required in EC §44274.2.

**(c)(3)(B):** ‘U.S. territory’ has been added to allow individuals residing in U.S. territories who have acceptable teaching experience to apply via the experience route. The language requiring that one of the performance evaluations be from the last two years of an individual’s verified experience has been deleted, because only two years of experience are required under the current experience route and the evaluation recency language is not included in EC §44274.2. Language has been added explaining that an individual who cannot provide two performance evaluations or a supplemental letter from separate years of the verified out-of-state teaching experience will not qualify via the experience route.

**(c)(4) through (c)(4)(F):** This subsection has been added to provide the definition for the 150 clock hours of activities that was previously provided in subsection (a)(2). The language of the definition has been amended slightly because, although EC §44274.2(b)(1) requires that the 150 clock hours of activities meet or exceed standards established by the Commission, it does not require that the activities be completed in California. Therefore, all references to ‘California’

employers and the requirement that the activities be completed in California while holding a preliminary teaching credential have been deleted. The word ‘public’ has been added to two places in the subsection and regionally accredited private school has been added to clarify the types of employers that may verify completion of the 150 clock hours of professional activities. In addition, ‘standards’ has been amended to the full title of ‘California Standards for the Teaching Profession (CSTP)’.

**(c)(5):** This subsection has been added to define the ‘professional level teaching credential’ term used throughout the proposed amendments to §80413.3.

**(d):** Section deleted due to the repeal of EC §44274 with the passage of Senate Bill (SB) 1209 (Chap. 517, Stats. 2006).

**(e):** Section deleted due to the repeal of EC §44274.4 in October 2000 with the passage of Assembly Bill (AB) 877 (Chap. 703, Stats. 2000).

**Note:** Added EC §44253.3 pertaining to the English learner authorization; §44257 pertaining to the statutory Single Subject Teaching Credential areas; §§44280, 44281, 44282, and 44310 pertaining to subject matter competence; and §§44339, 44340, and 44341 pertaining to fingerprint clearance to the reference section. Deleted §44274 due to the section’s repeal with the passage of SB 1209 and §44274.4 due to section’s repeal with the passage of AB 877.

### **§80430.2**

Entire section deleted due to the repeal of EC §44274 with the passage of SB 1209.

The Commission must determine that no reasonable alternative considered would be more effective in carrying out the purpose for which the action is proposed or would be as effective as and less burdensome to affected private persons than the proposed actions.

1. The use of teaching strategies that motivates all students to engage in the learning process.
2. The ability to establish and maintain high standards for student behavior.
3. A demonstration of deep knowledge of the subject being taught and the use of appropriate instructional strategies that promote student understanding.
4. An ability to plan and implement a sequence of appropriate instructional activities.

(B) Evaluations of the teacher's performance for at least two of the years of teaching experience from a state or U.S. territory other than California must be submitted ~~with at least one evaluation within the last two years of the experience.~~ If evaluations or a supplemental letter covering two years of the verified out-of-state teaching experience cannot be obtained, the individual will not qualify under section (a).

(C) Evaluation ratings must be satisfactory or better.

(4) California Standards for the Teaching Profession (CSTP): The 150 clock hours of CSTP activities may be satisfied by staff development, college course work or other activities related to the CSTP. When applying for the clear credential, a written list of the activities including a justification stating how each of the activities relates to the CSTP must be attached. An individual at the central office of a public school district or county office of education, or at a public school site or a regionally accredited private school who is responsible for curriculum and instruction in the authorization of the teacher's credential

must sign the written justification agreeing that the activities relate to the CSTP as stated. The following are the six CSTP areas:

- (A) Engaging and supporting all students in learning.
- (B) Creating and maintaining effective environments for student learning.
- (C) Understanding and organizing subject matter for student learning.
- (D) Planning instruction and designing learning experiences for all students.
- (E) Assessing students for learning.
- (F) Developing as a professional educator.

(5) Professional Level Teaching Credential: This is defined as a teaching credential issued by another state or U.S. territory that is, at a minimum, comparable to a California five-year preliminary teaching credential.
