SUBJECT: Social Security or Tax Identification Number for Documents Issued by the

Commission on Teacher Credentialing

Summary:

Effective the date of this correspondence, the Commission on Teacher Credentialing will require every paper application and online application for all types of documents issued by the Commission, including a Certificate of Clearance, to include a Social Security Number (SSN) or an Individual Tax Identification Number (ITIN). This Coded Correspondence supersedes Coded Correspondence 02-0012.

Key Provisions:

Specific information is required on paper applications and online applications to allow the Commission to establish a new file for initial issuance of a credential or locate a previous file for credential holders. This includes a SSN or an ITIN.

Current law requires the Commission to collect a SSN or an ITIN from each applicant for purposes of complying with the State Licensing Match System (SLMS) program (Family Code section 17520) and the state tax delinquency program (Business and Professions Code section 494.5).

Any application received after the date of this correspondence that does not include either a SSN or an ITIN will not be processed and will be returned as incomplete. Once the application is completed with a SSN or an ITIN, the application may be returned with the appropriate application fee and supporting materials to the Commission for processing.

Background:

The SLMS program prevents a parent who fails to pay court ordered child support from being issued an initial credential or renewing an existing credential without first paying, or making an agreement to pay, court ordered child support. Additionally, the program requires the

Commission to suspend any valid credentials held in the event a parent is delinquent with their child support payments.

A state licensing entity is required to refuse to issue, reinstate or renew a license if the applicant or licensee has outstanding tax obligations due to the Franchise Tax Board (FTB) or the State Board of Equalization (BOE) and appears on either the FTB or BOE's certified lists of top 500 tax delinquencies over \$100,000.

The Commission is required to collect a SSN or an ITIN to carry out its duties under these laws.
