

## **Update on the Fourth Quarterly Report for Occidental College June 2012**

### **Overview of this Report**

This agenda item presents a report on the fourth and final quarterly report submitted by Occidental College as required by the COA.

### **Staff Recommendation**

Staff has reviewed the fourth quarterly report and action plan submitted by Occidental College pursuant to COA direction in June 2011. No action is required on this item at this time.

### **Background**

On June 23, 2011, the Committee on Accreditation, on behalf of the Commission on Teacher Credentialing, assigned the status of *Accreditation with Probationary Stipulations* to Occidental College and its approved Multiple and Single Subject Preliminary credential program (<http://www.ctc.ca.gov/educator-prep/coa-agendas/2011-06/2011-06-item-16.pdf>). The institution has requested and been approved to withdraw all accreditation programs as of June 30, 2012.

In accordance with the stipulations placed upon Occidental College in June 2011, Occidental College submitted its initial action plan on July 15, 2011 to address all stipulations. At the October 27, 2011 COA meeting, staff presented an update on the work completed by Occidental College as of September 23, 2011 as well as the results of the revisit that took place October 6-7, 2011 (<http://www.ctc.ca.gov/educator-prep/coa-agendas/2011-10/2011-10-item-09.pdf>). At the February 1-2, 2012 meeting, staff presented a subsequent update as provided by Occidental College in the second quarter (<http://www.ctc.ca.gov/educator-prep/coa-agendas/2012-02/2012-02-item-23.pdf>). At the April 19th meeting, after hearing the third and final quarterly report (<http://www.ctc.ca.gov/educator-prep/coa-agendas/2012-04/2012-04-item-25.pdf>), the Committee on Accreditation requested a final report from the college by June 15th to ensure that the COA has a thorough and updated accounting of whether all credential candidates have completed all program and credential requirements. This final report to the COA includes an update of the remaining 11 credential candidates relative to their passing of the TPAs and a plan to address the non-TPA completers/passers. Additionally, the college has included an update on TPA passage rates from previous cohorts dating back to the 2007-2008 academic year. A table representing the following information is presented as Appendix A.

### **Final Report**

#### **Current Cohort 2011– 2012 (N = 11)**

Occidental College's Department of Education provided students with a deadline of June 18<sup>th</sup> to submit their TPAs. Scoring of these submissions is ongoing. An update of

additional submissions and/or passage rates will be provided at the meeting as an agenda insert.

#### Current Submissions and Passage Record as of June 15th, 2012 (N=11)

- One student has passed ALL TPA Tasks
- Seven students have passed TPAs 1, 2, & 4
  - Six of these seven students have submitted TPA Task 3
  - One expects to submit TPA Task 3 by Monday, June 18th
- One student has passed Tasks 1 & 2 and has submitted Tasks 3 & 4
- One student has passed Tasks 1 & 2 and has submitted Task 4 (but not Task 3)
- One student has not submitted TPA Task 3 & 4
- One student has not submitted TPA Task 3

#### Plan for TPA Non-Completers

The Dean has hired Occidental College's Credential Analyst for the summer months (July and August) to assist students in finding other credential programs in which to finish/pass their TPAs and to process all credential recommendations during the 90 day recommendation grace period.

Students can continue to use the Occidental Education Department Curriculum Library and other materials to help them prepare for passing the remaining TPAs. Department faculty will be available to assist students in finding other credential programs.

#### **Update on Previous Cohorts**

##### Cohort 2010 – 2011 (N = 15)

- Thirteen Candidates passed all TPA Tasks
- Two candidates have submitted their one remaining TPA Task.

##### Cohort 2009 – 2010 (N = 11)

- All 11 candidates passed the TPA Tasks

##### Cohort 2008 – 2009 (N = 15)

- Twelve candidates passed all TPA Tasks
- One candidate has not submitted one TPA Task
- Two candidates have not submitted two TPA Tasks

##### Cohort 2007 – 2008 (N = 15)

- Thirteen candidates passed all TPAs
- One candidate passed 1 TPA and plans to submit the remaining 3 TPA Tasks
- One candidate passed 1 TPA and plans to submit the remaining 3 TPA Tasks

Occidental College now has 58 of 67 candidates between 2007-2012 who have completed both the coursework and TPA tasks required to earn the preliminary multiple or single subject teaching credential, with two weeks remaining before the program closes. The

nine remaining candidates represent 13% of the possible candidate pool.

**Next Steps**

Commission staff will continue to monitor the progress to completion of the 11 current candidates through September 30, 2012.
