Discussion of COA Meeting Dates for 2019 June 2018

Overview of this Report

This agenda item proposes COA meeting dates for the 2019 calendar year.

Staff Recommendation

That the COA takes action to adopt a meeting schedule for the 2019 calendar year.

Background

Staff has prepared a proposed schedule of COA meeting dates for the 2019 calendar year with a few options to discuss. Members of the COA agreed that the preferred days to meet are Thursday and Friday. Staff proposes to continue this approach into 2019, whenever possible. Site visits for the yellow cohort will resume beginning in the fall of 2018 and, therefore, staff proposes all two day meetings for 2019 at this point in time, with the exception of August 2019 which is proposed to be a one day meeting.

Consideration has been given to Commission meeting dates as well as state, federal and religious holidays. Consideration was also given to the dates that the Committee of Credentials meets, when possible. Generally, the Committee of Credentials meets the third week of the month. There may be some unavoidable instances in which the COA and COC will be meeting the same week.

Lastly, the Commission staff considers the COA workload. For the past two years the COA acted on dates through the end of the calendar year, bringing the COA schedule setting in line with the Commission.
