#### Item 1 - CALL TO ORDER AND ROLL CALL

The August meeting of the Committee on Accreditation was called to order by Co-Chair Anna Moore at 1:06 p.m. on Monday, August 6, 2018.

Co-Chair Moore welcomed and introduced the three new COA members:

#### Item 2 - APPROVAL OF THE AGENDA

It was moved, seconded (Borgese/Forbes) and carried by roll call vote to approve the August 2018 agenda.

## Item 3 - APPROVAL OF THE MINUTES OF THE PRIOR MEETING

A request was made by committee member Alvarado to remove the word "find" on page 2, Item 5 paragraph 2. It was moved, seconded (Forbes/Borgese) and carried by roll call vote to approve the June 2018 minutes with committee member Alvarado's requested edit as follows:

"Ms. Hickey reported that the recipients of the integrated program grants will be surveyed to find get a better sense of who is enrolling candidates this fall since they do not have to go through a new approval process."

Cynthia Amos, Cathy Creasia, Katrine Czajkowski have abstained from this item.

## Item 4 - CO-CHAIR AND MEMBER REPORTS

Committee member Forbes reported on the Request for Proposal (RFP) that was just released from the California Teacher Education Research and Improvement Network that is funded by the UC office of the President. They are looking to award funding projects that involve multiple segments and also K-12 in research on teacher education and improvement.

Committee member Frelly discussed progress being made on the development of the Teaching Performance Assessment (TPA). The first field tests have been completed. The CalTPA has been redesigned slightly as a result of the feedback from the field test. The lead assessors have looked at the new test format and made comments that had gone to the Commission this month (August 2, 2018) for approval.

#### Item 5 – STAFF REPORTS

Administrator Hickey discussed a variety of items relevant to the Commission's work. She announced the Governor's budget has been signed and included substantial resources for residencies and local solutions. An appropriation of \$75 million was included in the budget for teacher residencies (\$50 million for special education and \$25 million for bilingual or STEM grants). Additionally, \$50 million will be allocated for local solutions which is a broader category of how to meet the teacher shortage which will be for special education only. She also reported that the first revised Board of Institutional Reviewer (BIR) trainings will take place in August, September, and October with approximately 30 people in each session. The Commission approved new Education Specialist program standards and Teaching Performance Expectations. New names for approved for the two main categories of credentials are: Education Specialist Mild/Moderate Support Needs and Education Specialist Extensive Support Needs. Looking at full implementation in 2020. Administrator Kearney asked the COA to help spread the news that the survey is now open for those interested in volunteering for upcoming Program Reviews. The link to the survey is available on the PSD e-news.
