

Initial Program Approval for New Program Sponsors May 2020

Overview

This report consists of a recommendation made for the initial approval of two professional preparation programs for an institution that recently received Provisional Approval as a new program sponsor in California. Alder Graduate School of Education (Alder GSE), an institution of higher education (IHE), received Provisional Approval by the Commission at its [January 2020 meeting](#). Alder GSE now seeks approval from the Committee on Accreditation (COA) to offer both a preliminary multiple subject program and preliminary single subject program.

Staff Recommendation

That after discussion with the program sponsor, review of the BIR feedback, and review of the of the proposed program proposal documentation, the COA grant initial accreditation to the preliminary multiple subject and preliminary single subject program.

Background

The Commission requires that an institution seeking to offer new educator preparation program(s) must first be approved for initial accreditation as a new program sponsor and must do so by completing the Commission's Initial Institution Approval (IIA) process. At the [December 2015](#) meeting, the Commission approved a new IIA process requiring the satisfactory completion of five approval stages as part of the Strengthening and Streamlining Accreditation project – updates to the IIA process were subsequently approved during the [February 2016](#) meeting. A graphic detailing the five stages of the IIA process is provided on the following page.

Alder Graduate School of Education

Alder Graduate School of Education (GSE) has completed the first three stages of the Initial Institutional Approval process as follows:

Stage	Date

As previously discussed, Alder GSE appeared before the Commission at its January 2020 Commission meeting and its proposal for Provisional Approval was approved. Alder GSE’s responses to the preliminary multiple and single subject program standards were reviewed by a team of Board of Institutional Review members. Reviewers collaborated on the feedback and found all standards to be **Met**. Below is a summary of Alder GSE’s responses to the preliminary multiple and single subject program standards. Institution Summary

Alder Graduate School of Education was accredited by the Western Association of Schools and Colleges in 2019. Since 2010, Alder GSE has partnered with the University of the Pacific to prepare teachers using a teacher residency model refined over the last decade. Alder GSE’s mission is to “create opportunity and cultivate success for every student by recruiting and educating excellent teachers and leaders who reflect our schools’ communities.”

To do so, Alder GSE will immerse residents (teacher candidates) in theory through graduate-level courses while also providing them with the opportunity to apply that theory in practice via an apprenticeship with a highly-effective teacher. Alder GSE residents will earn a master’s degree and a teaching credential, embodying California’s Teaching Performance Expectations. By deeply examining core theory and beliefs that are foundational to the field, engaging in deliberate practice around teaching skills, and passing rigorous performance assessments, Alder GSE endeavors to ensure that its graduates will be prepared to be effective on their first day in the classroom and throughout their teaching careers. Alder aims to become a member of the California academy of teacher preparation institutions, preparing aspiring educators to enter the worthiest of professions -- teaching.
