Discussion of COA Meeting Dates for 2021 May 2020

Overview of this Report

This agenda item proposes possible COA meeting dates for the 2021 calendar year.

Staff Recommendation

Originally, this item was planned as an action item. However, due to the uncertainty created by the COVID 19 pandemic, staff is seeking more time to consider various factors in establishing the 2021 schedule of meetings. Staff proposes that the COA discuss the potential calendar for 2021 and staff will return in June with another set of recommendations for further considerations and possible adoption.

Background

Staff has prepared a proposed schedule of COA meeting dates for the 2021 calendar year with a few options to discuss. In the past, members of the COA agreed that the preferred days to meet are Thursday and Friday. But this was in question earlier this past year. Members of COA may want to discuss whether Thursdays and Fridays are still the preferred days or whether other days of the week would be more appropriate.

At this time, the proposed calendar would continue this approach into 2021, whenever possible. Site visits for the red cohort will begin in the fall of 2020 and, therefore, staff proposes all two day meetings for 2021 at this point in time, with the exception of August 2021 which is proposed to be a one day meeting.

Consideration has been given to Commission meeting dates as well as state, federal and religious holidays. Consideration was also given to the dates that the Committee of Credentials meets, when possible. Generally, the Committee of Credentials meets the third week of the month. There may be some unavoidable instances in which the COA and COC will be meeting the same week.

The following two charts lists the dates for the Commission schedule and the Committee of Credentials.

While the Commission attempts to avoid conflicts with spring break for educational institutions, the different educational institutions have widely varying spring breaks so it is not possible to avoid all conflicts.

In addition, the proposed possible dates have been selected to avoid conflicts with the following annual educational conferences. Some of those below are estimated times based on previous years. Staff was unable to confirm many of the conference dates given the current situation.

Lastly, the Commission staff considers the COA workload. For instance, toward the end of the site visit "season" the schedule should take into consideration getting as many site visit reports on for action as possible before the end of the academic year. While it is permissible to have site visit reports in the late summer (August) COA meetings, it is not ideal as team leads, institutional personnel and other relevant stakeholders are frequently unavailable.

The Commission sets its meeting schedule on a calendar year basis. For the past two years the COA acted on dates through the end of the calendar year, bringing the COA schedule setting in line with the Commission. Provided below are the *adopted* COA meeting dates for Fall 2020 and the *proposed* possible meeting date options for 2021.
