Notification of Institutions Not In Compliance with Accreditation Timelines October 2020

Overview

This regular report provides information to the COA regarding institutions that have not complied with the timelines of the accreditation cycle. Specifically, this item generally covers submission of Common Standards, submission of preconditions, submission of Program Review documentation, accreditation fees, and submission of data for the annual Accreditation Data System (ADS).

In addition, due to the recent school closures related to the COVID-19 crisis, the preconditions due date was extended to Friday, May 15, 2020 for the Violet and Green cohorts. In addition, the deadline to create program decks for the Annual Accreditation Data System was extended through May 15, 2020 as well.

This report provides an update to the Notification of Institutions Not In Compliance with Accreditation Timelines report presented at the June 2020 COA meeting.

Preconditions for the Violet and Green Cohorts were due on May 15, 2020. These two cohorts are comprised of 63 institutions. All preconditions have been received. After review of the preconditions, staff is working with institutions to submit their final feedback and revisions.

Annual Data Submission As a component of the accreditation process, Commission-approved institutions are required to annually submit data on their approved educator preparation programs. Institutions were asked to create their report decks by May 15, 2020.
