Discussion of Proposed COA Meeting Dates for 2024 June 2023

Overview of this Report

This agenda item proposes possible COA meeting dates for the 2024 calendar year.

Staff Recommendation

That the COA take action to adopt a meeting schedule for the 2024 calendar year.

Background

Staff has prepared a proposed schedule of COA meeting dates for the 2024 calendar year with a few options to discuss. In the past, members of the COA agreed that the preferred days to meet are Thursday and Friday. At this time, the proposed calendar would continue this approach into 2024, whenever possible. Site visits for the Blue cohort will begin in the fall of 2023. Staff proposes all meetings for 2024 be two-day meetings, with the exception of August 2024 which is proposed to be a one-day meeting.

Consideration has been given to Commission meeting dates as well as state, federal, and religious holidays. Consideration was also given to the dates that the Committee of Credentials meets. Generally, the Committee of Credentials meets the third week of the month and given that the Commission meeting room is used for both committees, they cannot meet at the same time.

The following two charts list the adopted dates for the Commission schedule and the prospective dates for the Committee of Credentials.

While the Commission attempts to avoid conflicts with spring break for educational institutions, the different educational institutions have widely varying spring breaks so it is not possible to avoid all conflicts.

Lastly, the Commission staff considers the COA workload. For instance, toward the end of the site visit "season" the schedule should take into consideration getting as many site visit reports as possible before the COA for action before the end of the academic year. While it is permissible to have site visit reports in the late summer (August) COA meetings, it is not ideal as team leads, institutional personnel, and other relevant stakeholders are frequently unavailable.

The Commission sets its meeting schedule on a calendar year basis. For the past two years the COA acted on dates through the end of the calendar year, bringing the COA schedule setting in line with the Commission. Provided below are the *adopted* COA meeting dates for Fall 2023 and the *proposed* meeting date options for 2024.

Staff notes that August meeting for 2023 is scheduled to be via videoconference, however, the COA may wish to reconsider whether it wishes to meet in person.
