1.	Is your program on the semester or quarter system?	All Programs	Select "Not Applicable" if the program does not use either the semester or quarter system.
2.	What is the number of units required for completion of the program?	All Programs	The number of units for program completion does not include the number of units needed to earn a degree. It is the number of units required in order for newly enrolled candidates to complete all program requirements and be recommended for the credential or authorization. If the program does not operate in a unit based environment, enter 0.00 for this question.
3.	In months, what is the expected length of the program for full-time candidates?	All Programs	The definition for full-time is at the discretion of the institution. The Commission is interested in understanding how long, in months, it is expected to take for candidates to finish the program when enrolled on a full-time basis. For Induction programs, two years should be entered as 20 months.
4.	In months, what is the expected length of the program for part-time candidates?	All Programs	The definition for part-time is at the discretion of the institution. The Commission is interested in understanding how long, in months, it is expected to take for candidates to finish the program when enrolled on a part-time basis. If no candidates complete your program in a part-time process, enter 0.00. For induction programs, the time basis of the candidate's employment (Part-Time/Full Time) is not relevant to this question.
5.	What is the total number of hours of clinical practice required?	All Programs	See Common Standard 3, page 4. For Induction programs, the clinical practice hours are the time the candidate works with the mentor or coach.
6.	Out of the mandated total 600 clinical practice hours, what is the number of student teaching hours required?	Preliminary Teaching	For additional information, see Clinical Practice Guidance (September 2017).
7.	What is the number of fieldwork hours required for interns prior to internship?	Preliminary Teaching	Intern Pathway Report ONLY: Fieldwork includes observation, small group teaching, and one on one tutoring.
8.	Does the program require demonstration of basic skills for admission?	Selected Programs	Please answer Yes if the demonstration of basic skills, whether an attempt or passage, is required for admission.
9.	Does the program require demonstration of subject matter for admission?	Preliminary Teaching	Please answer Yes if the demonstration of subject matter, whether an attempt or completion, is required for admission.
10.	What is the required minimum GPA for admission, if specified?	All Programs	The required minimum GPA for admission into the program. Enter "0.00" if no minimum GPA is required for admission.
11.	Out of all applications received, what percentage of applicants were admitted?	All Programs	Calculate the number of applicants that were actually accepted out of the total received for the reporting year. 13.	What is the number of master teachers who worked with candidates in their final student teaching placement during the prior academic year?	Preliminary Teaching	This data will be used to calculate the response rate for the Master Teacher Survey.
14.	What is the number of mentors/coaches working with enrolled candidates?	Induction	Count the number of mentors/coaches who work with newly enrolled candidates for the current reporting year.
15.	What is the number of new candidates who have satisfied basic skills at admission?	Preliminary Teaching	Count the number of newly enrolled candidates who have met the institution's basic skills requirement at admission.
