Subject: Update on the Implementation of the Strengthened and Streamlined Accreditation System – Transition of Institutions to New Accreditation System

**Summary** This Program Sponsor Alert is intended to update program sponsors regarding the transition to the newly strengthened and streamlined accreditation system. It is the first in what will be a series of alerts regarding the requirements for institutions to fully transition to the new accreditation system by 2017-18.

**Background** The Commission began work on redesigning the accreditation system in 2014 with the formation of, and input from, six task groups. The task groups were assigned to one of the following topics: Multiple/Single Subject Preliminary Program Standards; Induction Standards, Policies and Regulations; Public Access and Data Warehouse; Accreditation Processes and Procedures; Outcomes and Survey Data; and Performance Assessments. At the August 2015 meeting, the Commission approved a plan for transition to the new accreditation system. This transition plan was developed with the understanding that at this time, all the details of each component of the new accreditation are not yet finalized and that additional aspects of the accreditation policy work will need to be presented and approved by the Commission in the coming months. However, it was important for the Commission to adopt a transition plan in order to ensure the smooth phase out of the current system and to bring all Commission approved institutions in alignment with the new system as quickly and efficiently as possible. This plan provides time

for both the further development of the additional work necessary and extensive technical assistance so that all institutions are transitioned to the new accreditation system by 2017-18.

The plan focuses on significant technical assistance to assist program sponsors in revising their programs (multiple subject, single subject, and induction), revising Common Standards, and in meeting the requirements of the revised accreditation cycle, including new procedures and requirements related to data once the data warehouse is developed. To ensure adequate time for these revisions and preparation, a “development and transition year” has been inserted into the current cycle during 2016-17. Transition activities will take the place of current accreditation activities during that year and future Program Sponsor Alerts will provide greater detail on these specific activities.

The majority of activities in 2015-16 will remain the same, however to provide for the transition, several cohorts will be asked to also submit updated preconditions (PSA to follow) beginning in the spring 2016. Additionally, in 2016-17, all institutions will be required to respond to survey data. An upcoming PSA will provide further information regarding expectations for survey data responses. So that all institutions can adequately prepare for both the 2015-16 and 2016-17 academic years, and understand what will be expected in the first year (2017-18) of the new cycle, a summary of activities due to the Commission is provided in the Appendix.

### **Upcoming Information Relating Only to Transition to New Accreditation System**

This alert is an overview and staff understands that more information will be needed so that all institutions will be adequately prepared to move into the new system by 2017-18. Every effort will be made to keep stakeholders apprised of new developments and Commission action.
