Subject: Guidance for Teacher Preparation Programs for Title II requirements for Supervised Clinical Experience

Summary

This alert provides information on Title II requirements: (i) when and which teacher preparation programs must submit data for Title II report and (ii) specific guidelines on "Supervised Clinical Experience Hours" by routes.

Background – Why do Teacher Preparation Programs have to submit Title II? Title II is a federal mandate. Sections 205 through 208 (ACCOUNTABILITY FOR PROGRAMS THAT PREPARE – INSTITUTIONAL AND PROGRAM REPORT CARDS ON THE QUALITY OF TEACHER PREPARATION) of the Higher Education Opportunity Act (HEOA) call for accountability for programs that prepare teachers. HEOA was signed in 1998 and legislation was reauthorized in 2008. HEOA mandates that U.S. Department of Education (ED) collect data on state assessments, other requirements, and standards for initial teacher certification and licensure, as well as data on the performance of preparation programs. The law requires the Secretary of U.S. Department of Education to use these data in submitting an annual report on the quality of teacher preparation to the Congress.

Title II Reporting Requirements

HEOA requires that initial teacher preparation programs report on the following sections: Admission Requirements, Enrollment, Supervised Clinical Experience, Certification, Program Completers, Annual Goals, Assurances, Pass Rates for Program Completers and Enrolled Students, Low-Performing Program, Use of Technology, and Teacher Training.

When do programs submit Title II reports?

ED's Title II reporting timeframe is September 1 through August 31. Institutional and Program Report Cards (IPRCs) and a consolidated state report are due annually – April 30 and October 31, respectively. Which programs must submit Title II reports?

Teacher preparation programs that enroll first-time teacher candidates (individuals who do not hold an existing teaching credential) must submit a Title II report. This includes Commission-approved institutions that are provisionally approved and fully accredited that offer a preliminary and or intern program.

Supervised Clinical Experience

Information on Supervised Clinical Experience is reported in the IPRC. This section requires data on the number of:

- 1) supervised clinical experience hours required prior to student teaching
- 2) supervised clinical experience hours required for student teaching
- 3) supervised clinical experience hours required for mentoring
- 4) Full-Time Equivalent (FTE) faculty in supervised clinical experience
- 5) adjunct faculty involved in supervised clinical experience, and
- 6) candidates participating in supervised clinical experience.

Since Title II is a federal mandate, all definitions come from the ED.

Definition from Federal Title II guidelines:

A series of supervised field experiences (including student teaching) with PK-12 students that occur as a sequenced, integral part of the preparation program prior to the candidate becoming the teacher of record. Please note that Title II, Section 202 (d)(2) describes features of clinical experience as follows. Courses in the curriculum that include the activities described in 202(d)(2) may be considered clinical coursework. The curriculum policies of each state and its institutions will identify coursework that is clinical and nonclinical.

In the current IPRCs, the supervised clinical experience questions are asked for all routes – Traditional (Student teaching), Alternative, IHE-based (University Intern), and Alternative non-IHE-based (District Intern). There is a 600-hour requirement of supervised clinical practice for all general education and education specialist candidates, regardless of pathway, in Program Standard 3 of the Commission's Educator Preparation Program Standards.

Based on California Title 5 Regulations, all interns are required to receive 189 hours of clinical support and supervision, (144 hours of general support and 45 hours of EL support and supervision).

The tables below are provided to clarify how programs should report data for the section on **Supervised Clinical Experience** of the Title II (IPRC) report.
